RE: FY09 Budget Reduction Proposals for MH/DD Services as developed by the MH/DD Advisory Committee

The MH/DD Advisory Committee met on Friday, February 8, 2008 to discuss the FY09 budget and the need for a Plan of Reductions due to the lack of adequate funding from the State and the need to maintain a balanced budget.

A few members of the committee expressed concern about the negative publicity the proposed cuts/plan of reductions generates. After much discussion, the committee agreed to move forward with the development of a Plan of Reductions for FY09 and also wants to develop visual aids for Legislators to show the impact of the cuts in our community. The committee is meeting again on February 18, 2008 to develop the Plan of Reductions.

The committee will be looking at ten possible service areas to cut. The county's FY09 shortfall is \$983,170. The committee was given the MH/DD Funding Talking Points, the summary page showing the history of the county's fund balance, as well as a summary page describing the county's FY08 and FY09 budget. I will have copies of the proposed FY09 Budget Reductions as developed by the MH/DD Advisory Committee for the Committee of the Whole Meeting on February 19, 2008. The committee members have been invited to attend as well. The agencies affected by the reductions are aware of the financial crisis and will assist in advocating for adequate funding.

The reductions will go into effect on July 1, 2008 unless additional MH-DD funding is approved by the legislature and Governor during this legislative session.
