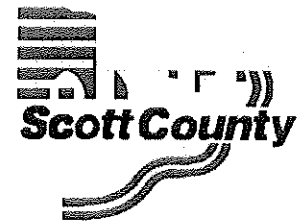

RE: Request to Abate Mobile Home Taxes

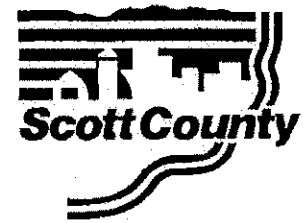
Pursuant to Iowa Code 445.56, I am requesting the Scott County Board of Supervisors to abate the mobile home tax for parcel 82U805956 for a mobile home in the name of Mary A. Cook located at 3624 State Street, Lot 12, Bettendorf, IA for the tax years 2001-2005. The base tax is \$106.00 for each year.

SCOTT COUNTY BOARD OF SUPERVISORS

January 8, 2009

SUSPENDING THE CURRENT PROPERTY TAXES FOR MARY A. COOK, 3624 STATE STREET, LOT 12, BETTENDORF, IOWA, IN THE AMOUNT OF \$501.

BE IT RESOLVED by the Scott County Board of Supervisors as follows:

- Section 1. The current property taxes and utility fees, interest and penalties accrued for Mary A Cook, Bettendorf, Iowa, 2006 taxes of \$167.00, 2007 taxes of \$97.00, 2008 taxes of \$129.00, and 2009 taxes of \$108.00 in the total amount of \$501.00 are hereby suspended.
- Section 2. The County Treasurer is hereby directed to suspend the collection of the above stated taxes and utility fees thereby establishing a lien on said property as required by law with future collection to include statutory interest, if any.
- Section 3. This resolution shall take effect immediately.
