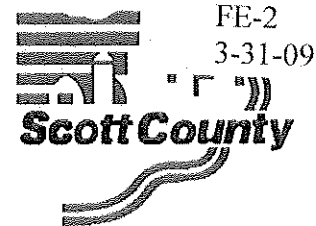

Parcel 020617102—L is a cabin identified as a building on leased land with unpaid taxes since the 2001 first installment under the ownership of Charles Wolfe. The amount due from 2001 through the current year is \$1,235.00 which includes the principle, interest and cost.

The land including the building was sold to Grage Living Trust from Charles Wolfe and most recently was transferred to James Halsey from Grage Living Trust. Grage Living Trust has agreed to pay the principle of \$560.00 for 2001-2005 tax years and James Halsey has agreed to pay the principle of \$194.00 for 2006 and 2007 tax years.

I am requesting the abatement of the interest and cost of \$481.00 pursuant to statute 445.16 after determining it impractical to pursue the collection of the total amount due.
