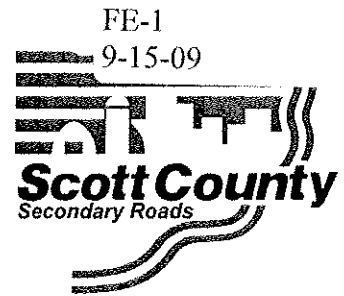

SUBJ: 3rd Reading for Speed Limits

DATE: September 15, 2009

Third of three readings of ordinance for establishing a new speed limit on the following county streets:

1. Reducing the speed limit on 260th Av. from 225th St to 235th St., Scott Co. - for safety concerns. Residents living on the road have requested the reduction of speed along this road.
2. Reducing the speed limit on Slopertown Road from 145th Av (Hillandale Rd) West to 115th Av (Y52).
3. Reducing the speed limit on 257th Av from Territorial Road South to 200th Street and East on 200th Street to the LeClaire City Limits.

After studying the traffic - including bus routes, population and geometrics of these roadways I recommend reducing the speed limits to 45 mph.

SCOTT COUNTY ORDINANCE NO 09-

AN ORDINANCE TO AMEND CHAPTER 13-34 OF THE SCOTT COUNTY CODE
RELATIVE TO DESIGNATED SPEED LIMITS ON SCOTT COUNTY SECONDARY
ROADS.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Add to Sec. 13-34R , Add Item Nos. 7, 8, and 9 to read:

R. County

7. 45 MPH - On 260th Avenue from 225th Street to
235th Street.
8. 45 MPH - On Slopertown Road from 145th Av
(Hillandale) West to 115th Av (Y52).
9. 45 MPH - On 257th Av from Territorial Road South
to 200th Street and East on 200th Street to LeClaire
City Limits.

SECTION 2.

The County Auditor is directed to keep and maintain a copy
of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason
illegal or void, then the lawful provisions of this
Ordinance shall be and remain in full force and effect,
The same as if the Ordinance contained no illegal or void
provisions.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with the
provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its
final passage and publication as by law provided.
