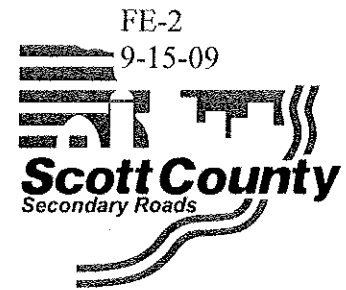

SUBJ: 3<sup>rd</sup> Reading for Stop Signs

DATE: September 15, 2009

Third of three readings of an ordinance for establishing new stop signs located at: the intersection of 205<sup>th</sup> Street and 257<sup>th</sup> Av. – from the east and west entrances making this intersection a 4-way stop.

AN ORDINANCE TO AMEND CHAPTER 13, SEC. 13-47-A(7), LECLAIRE TOWNSHIP OF THE SCOTT COUNTY CODE RELATIVE TO PLACEMENT OF STOP SIGNS ON SCOTT COUNTY SECONDARY ROADS.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Under Sec. 13-47-A (7), add Item No. y to read:

From the East and West entrances at the intersection of 205<sup>th</sup> Street and 257<sup>th</sup> Avenue.

SECTION 2.

The County Auditor is directed to keep and maintain a copy of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason illegal or void, then the lawful provisions of this Ordinance shall be and remain in full force and effect, the same as if the Ordinance contained no illegal or void provisions.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its final passage and publication as by law provided.
