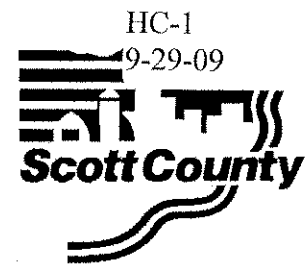

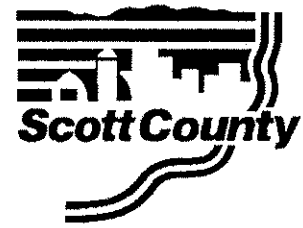

**BE IT RESOLVED by the Scott County Board of Supervisors as follows:**

- Section 1. That Scott County has been directed by the Iowa Department of Human Services to suspend the collection of property taxes, assessments and rates or charges, including interest, fees, and costs for Angelic Jolene Smith, 4228 Warren Street, Davenport, Iowa, in the amount of \$2289.00 (2008 property taxes) and \$372.62 (utility fess of \$97.46 receipt number: 485546, 2009 Special Assessment, \$88.50 receipt number: 492103, 2009 Special Assessment, \$92.34 receipt number 498941, 2009 Special Assessment, \$94.32 receipt number: 504814, 2009 Special Assessment) are hereby suspended.

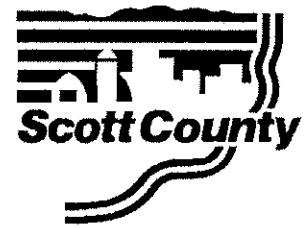
