Subj: Squad car replacement bids for the Sheriff's Office

The Sheriff's Office is budgeted to replace six Class 1 squad cars during the current fiscal year. We solicited bids for 2010 Ford Crown Victoria Police Interceptors (CVPI) using the same bid specifications used the past two years. Those bids are summarized below:

| Stivers Ford (Iowa State Contract) | \$25,734.00 |

During the bid process, Stivers Ford made the Sheriff aware that they had several 2009 squad cars still in stock at a much reduced per unit price. The units that they have available do not match our specifications exactly, however the Sheriff and his staff evaluated the 2009 units and determined that despite slighter higher outfitting costs (for wiring of aftermarket equipment and rekeying locks) the 2009 units would save us between \$6 - 10,000 in total. The 2009 units fare available for \$22,616 each, saving nearly \$3000 per unit. Stivers Ford has four units available.

I recommend the purchase of the two 2010 Ford CVPI squad cars from the low bidder, Reynolds Ford in the total amount of \$51,220. In addition, I recommend the purchase of four 2009 Ford CVPI squad cars from Stivers Ford in the total amount of \$90,334.00. The total of the two purchases is \$141,554.00. This purchase is budgeted in the current fiscal year in the amount of \$150,000. I plan to attend the next Committee of the Whole meeting to answer any questions you or the Board may have.
