AN AGREEMENT AMONG
BI-STATE REGIONAL COMMISSION AND
THE GOVERNMENTS OF
BETTENDORF, DAVENPORT AND SCOTT COUNTY, IOWA; AND
EAST MOLINE, MOLINE, ROCK ISLAND, AND ROCK ISLAND
COUNTY, ILLINOIS

FOR CONTRACTUAL SERVICES RELATED TO THE HOLDING AND ADMINISTRATION OF A CONTRACT FOR LEGISLATIVE TECHNICAL ASSISTANCE

This agreement, is entered into by the Bi-State Regional Commission and the governments of Bettendorf, Davenport, and Scott County, Iowa; East Moline, Moline, Rock Island, and Rock Island County, Illinois for contractual services related to the holding and administration of a contract for legislative technical support.

WHEREAS, the parties hereto are desirous and capable of entering into an agreement for procurement of services specified herein.

THEREFORE, THE PARTIES HERETO agree to the following terms and conditions:

- A. Bi-State Regional Commission staff shall annually enter into a contract with a firm for the provision of legislative technical assistance to benefit the interests of the governments of Bettendorf, Davenport, and Scott County, Iowa; East Moline, Moline, Rock Island, and Rock Island County, Illinois. The contracted firm will have expertise in the areas of national defense policy, U.S. Army arsenals, and federal base closure or realignment policy.
- B. Funding for said contract will be provided entirely by the governments of Bettendorf, Davenport, and Scott County, Iowa; East Moline, Moline, Rock Island, and Rock Island County, Illinois. These funds shall be received separate from any membership dues or other contracts between said governments and Bi-State Regional Commission and shall be non-federal dollars.
- C. Bi-State Regional Commission will collect, hold, and account for these funds separately.
- D. In no instance shall Bi-State Regional Commission make payment for said contract using any federal or state grant dollars, its membership dues or other funds not specified under this contract.

- E. Said contract shall be funded exclusively by the governments of Bettendorf, Davenport, and Scott County, Iowa; East Moline, Moline, Rock Island, and Rock Island County, Illinois in the following manner, with all funds to be received by Bi-State Regional Commission no later than November 30th each year.
 - 1. City of Bettendorf, IA \$11,500
 - 2. City of Davenport, IA \$26,500
 - 3. City East Moline, IL \$4,900
 - 4. City of Moline, IL \$13,200
 - 5. City of Rock Island \$10,000
 - 6. Rock Island County, IL \$15,000
 - 7. Scott County, IA \$15,000
- F. To the full extent permitted by law, the governments of Bettendorf, Davenport, and Scott County, Iowa; East Moline, Moline, Rock Island, and Rock Island County, Illinois, shall indemnify, defend and hold harmless Bi-State Regional Commission, its staff, officers and agents from and against any and all claims, damages, losses and expenses, legal or otherwise, incurred by Bi-State Regional Commission in the defense of any claims or suit brought as a result of this agreement.
- G. If any section, provision, or part of this agreement shall be found to be invalid or unconstitutional, such judgment shall not affect the validity of the agreement as a whole or any section, provision, or part thereof not found to be invalid or unconstitutional.
- H. This agreement may be amended or terminated by mutual written consent of the participants to this agreement and upon meeting obligations of any contracted services made under this agreement.
