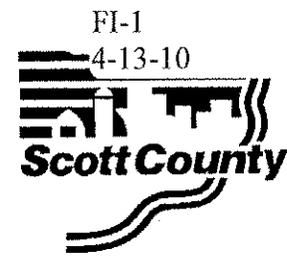

 Subject: Approval of Purchase of Cisco network equipment for SECC and Scott County

Bids have been received for the purchase of Cisco network equipment to facilitate the startup of the Scott Emergency Communications Center (SECC) and the upgrade of the phone system at Scott County.

This network equipment will establish core and edge networking at SECC and replace such equipment at the County. The equipment will facilitate current technology including Voice over Internet Protocol (VoIP), Power over Ethernet (PoE) as well as provide growth capabilities for the next decade or longer.
