RE: RFP Mental Health Services in Jail/Juvenile Detention Center

As you are aware, an RFP was sent out to solicit interest in providing mental health servicesscreening, assessment and prescription service for the inmates in the jail and juveniles in the detention center who may be suffering from mental health issues.

A committee made up of Health Department staff, Jail staff and myself reviewed the RFP's and have selected Genesis Psychology Associates to be the provider for FY11. Psychology Associates is willing to provide mental health screening, medication evaluation and follow-up and mental health screenings in the Juvenile Detention Center. The number of hours of service listed in the RFP is higher than what is currently being provided. Jail staff felt the number of hours needed would in reality be lower. The number of hours needed various significantly based on the jail population. The service will be billed through the United HealthCare insurance pilot project.

The committee plans to meet with the new provider to discuss procedures and policies prior to July 1. The Health Department and Jail staff look forward to working with Genesis Psychology Associates.

I will be at the Committee of the Whole meeting to answer questions.
