Subj: Vehicle bids for the Sheriff's Office

The Sheriff has reassigned a deputy from the Patrol Division to Investigations and is in need of an additional investigator vehicle (unmarked, traditional sedan; non-law enforcement models) for that person. We solicited bids for a mid-sized, two-wheel drive SUV to fill that need. Attached is a spreadsheet that summarizes those bids.

As the spreadsheet illustrates the Ford Escape has both the lowest initial capital cost as well as the lowest cost of combined capital and fuel expense over the expected life of the vehicle. The fuel costs are based on an eight year life of 80,000 miles (50/50 city/highway driving) and our estimate for future average gas prices (\$2.79 our average price over the next 8 years).

I recommend that the Board approve the bids and award the purchase to Reynold's Ford in the total amount of \$17,186.55. The Sheriff's Office has one investigative vehicle budgeted in FY11 in the amount of \$20,000. I will be available at the next Committee of the Whole meeting to answer any questions you or the Board may have.
