Subj: Squad car replacement bids for the Sheriff's Office

The Sheriff's Office is budgeted to replace six Class 1 squad cars during the current fiscal year. We solicited bids for 2011 Ford Crown Victoria Police Interceptors (CVPI) using the same bid specifications used the past several years. Those bids are summarized below:

### Class 5

<u>Dealer</u>	<u>Bid Amount (per unit)</u>
Lindquist Ford	\$24,965.00
Reynolds Ford	\$24,686.24
Stivers Ford (Iowa State Contract)	\$24,592.00

As you can see, Stivers Ford (the state contract) is the low bid. That bid amount includes delivery to the Tremont facility. The Sheriff wishes to purchase five units (instead of six that were budgeted) at this time. The SUV (Chevy Tahoe Police Package) used for the K-9 officer needs to be replaced, however pricing for the new Ford Explorer Police Package is not available at this time. The Sheriff wishes to bid that replacement later when bids for an Explorer could be considered. We expect that replacement to be in April or May.

For your information, this is the last year of production for the Ford Crown Victoria Police Package. Next year, the Sheriff plans to evaluate alternatives offered from the various manufacturers to select a replacement for their standard squad car for future purchases.

I recommend the purchase of five 2011 Ford CVPI squad cars from the low bidder, Stivers Ford in the total amount of \$122,960. This purchase is budgeted in the current fiscal year in the amount of \$162,000. I plan to attend the next Committee of the Whole meeting to answer any questions you or the Board may have.
