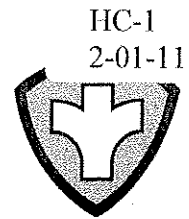

RE: Requested Contract Amendment with CADS FY'11 Contract

Scott County provides the Center for Alcohol & Drug Services, Inc. (CADS) with \$30,000 of county dollars and \$10,000 of state match dollars to defray costs of prevention services the agency provides in Scott County. Currently, CADS receives \$2,500 of county dollars on a monthly basis and \$2,500 of state dollars on a quarterly basis up to the maximum amounts previously specified.

The County's contract with the Iowa Department of Public Health requires that payments of the state dollars be on the basis of reimbursement of actual expenses. As a result, the county's contract with CADS needs to be amended. The amended contract will require that CADS submit a monthly, detailed accounting of actual expenses related to prevention services for reimbursement. The county will reimburse CADS for actual expenses up to the maximum amount specified in the contract.

I will be at the February 1, 2011 Committee of the Whole to answer any questions from the Board.
