Subj: Squad car replacement bids for the Sheriff's Office

As you may recall, the Sheriff asked for and the Board approved the purchase five of the six budgeted squad car replacements in January. The intent was to use the sixth budgeted unit to evaluate potential replacements for the discontinued Ford Crown Victoria. At that time we anticipated that Ford would release their new 2011 police package for the Explorer in April. Now we are hearing that release is delayed, possibly until the end of the calendar year.

The Sheriff would like to proceed with the purchase of an Explorer without the police wiring package to meet his replacement needs. Without the wiring package there will likely be additional costs for wiring to install the needed equipment. The Sheriff does not anticipate that cost to be excessive. At the Sheriff's request, we solicited and received the following bids:

<u>Vendor</u>	<u>Description</u>	<u>Unit Cost</u>
Lindquist	2010 Black Police Wiring 4X4 (unit would require painting at a cost of \$5000)	\$24,155.00
Lindquist	2011 White 4X4 (no wiring pkg.) (unit would require alternator and wiring at approx. \$600)	\$24,045.00
Reynolds	2011 White 4X4 (no wiring pkg.) (unit would require alternator and wiring at approx. \$600)	\$23,995.00

I recommend the purchase of one 2011 Ford Explorer 4X4 from the low bidder, Reynolds Ford in the amount of \$23,995. This purchase is budgeted in the current fiscal year and there is adequate funding available remaining to make this purchase. I plan to attend the next Committee of the Whole meeting to answer any questions you or the Board may have.
