Subj: Approval of award of bid for CCTV components

The Purchasing Division has solicited bids for a number of CCTV components for both the Jail and Juvenile Detention Center. The parts and pieces for the Jail are to add cameras to better cover the officer's workstation in each housing units. These parts include several new cameras, power supplies and a digital video recorder to increase capacity to record the new cameras. These parts would be funded from Risk Management funds as a safety enhancement.

Included in the bids is one digital video recorder for the Juvenile Detention Center to replace an existing unit that has failed. This part is funded from the Capital Improvement Fund as a security equipment replacement.
