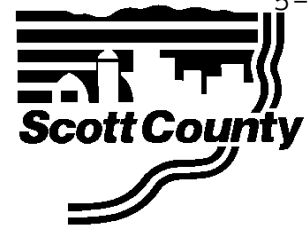

RE: Amendment to Agreement with Genesis Medical Center

Attached for consideration by the Board is an amendment to the agreement between Scott County and Genesis Medical Center. The amendment is for this fiscal year, starting 5/1/11.

The amendment serves two purposes: it sets rates for specific services and other counties utilizing Genesis behavioral health services will be expected to pay the same rate for the doctor's services. The original agreement did not cover physician rates and services. This amendment will be incorporated into the original agreement for next fiscal year.

**BE IT RESOLVED by the Scott County Board of Supervisors as follows:**

Section 1. The Amendment to the Agreement between Scott County and Genesis Medical Center Relating to Payment for Physician Services within the Behavioral Health Unit for the period May 1, 2011 through June 30, 2011 is approved.

Section 2. The Chairman is authorized to sign the Amendment to the Agreement.

Section 3. This resolution shall take effect May 1, 2011.

This amendment is effective May 1<sup>st</sup>, 2011 and is made to the agreement effective July 1<sup>st</sup>, 2010 between Scott County, Iowa, a governmental unit of the State of Iowa and Genesis Health System d/b/a Genesis Medical Center Davenport.

In consideration of the mutual covenants and agreements hereinafter set forth, Scott County and Genesis Medical Center Davenport agree as follows:

1. Genesis Physicians will provide the following services to residents of Scott County: psychiatric evaluation upon admission, hospital inpatient care and hospital discharge evaluation. Genesis will also provide upon request, medical testimony and paperwork.
2. Scott County agrees to provide payment to Genesis Medical Center Davenport for the above referenced services at the agreed upon rates listed below.
