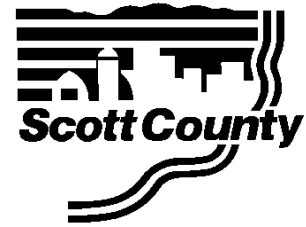

SUSPENDING THE CURRENT PROPERTY TAXES FOR JOAN ANNETTE GASZAK, 1807 SUTTON PLACE, BETTENDORF, IOWA, AS DIRECTED BY THE IOWA DEPARTMENT OF HUMAN SERVICES IN THE AMOUNT OF \$1420.00.

BE IT RESOLVED by the Scott County Board of Supervisors as follows:

- Section 1. That Scott County has been directed by the Iowa Department of Human Services to suspend the collection of property taxes, assessments and rates or charges, including interest, fees, and costs for Joan Gaszak, 1807 Sutton Place, Bettendorf, Iowa, in the amount of \$1420.00 (2010 property taxes due September 2011 and March 2012) are hereby suspended.
- Section 2.
