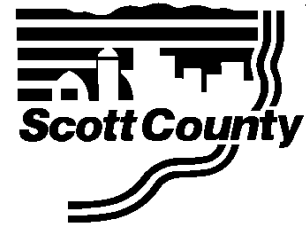

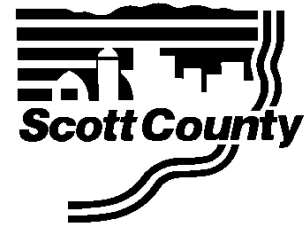
**SUSPENDING THE CURRENT PROPERTY TAXES FOR VALORIE ANDERSON, 1335 WEST 13<sup>TH</sup> STREET, DAVENPORT, IOWA, AS DIRECTED BY THE IOWA DEPARTMENT OF HUMAN SERVICES IN THE AMOUNT OF \$1312.00.**

**BE IT RESOLVED by the Scott County Board of Supervisors as follows:**

- Section 1. That Scott County has been directed by the Iowa Department of Human Services to suspend the collection of property taxes including interest, for Valorie Anderson, 1335 West 13<sup>th</sup> Street, Davenport, Iowa, in the amount of \$1312.00 including interest (2010 property taxes) are hereby suspended.
- Section 2. That the collection of all property taxes including interest, assessed against the parcel at 1335 West 13<sup>th</sup> Street, Davenport, Iowa remaining unpaid shall be suspended for such time as Valorie Anderson remains the owner of such property, and during the period he/she receives assistance as described in Iowa Code Section 427.9.
- Section 3. That the County Treasurer is hereby directed to suspend collection of the above stated taxes, assessments, and rates or charges, including interest, fees, and costs, thereby establishing a lien on said property as required by law, with future collection to include statutory interest.
- Section 4. This resolution shall take effect immediately.
