- SUBJ: Third reading of ordinance for establishing a new speed limit on county road.
- DATE: January 5, 2012

Third reading of an ordinance to adjust the speed limit on 278<sup>th</sup> Avenue and 264<sup>th</sup> Street, near Centennial Oaks subdivision.

Centennial Oaks is a residential Subdivision with several access points along this route. This is our newest macadam/paving project. The road has several curves which we designed at 45mph and one curve which is posted with an advisory speed at 25mph.

In our speed study 85<sup>th</sup> percentile was an average of 44.5 mph. I recommend a 45mph speed limit.



## SCOTT COUNTY ORDINANCE NO 12-

AN ORDINANCE TO AMEND CHAPTER 13-34 OF THE SCOTT COUNTY CODE RELATIVE TO DESIGNATED SPEED LIMITS ON SCOTT COUNTY SECONDARY ROADS.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Add to Sec. 13-34R, Add Item No. 10, to read:

R. County

10. 45 MPH - On  $278^{th}$  Avenue from Highway 67 south to  $264^{th}$  Street then west to the west edge of Centennial Oaks subdivision.

SECTION 2.

The County Auditor is directed to keep and maintain a copy of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason illegal or void, then the lawful provisions of this Ordinance shall be and remain in full force and effect, The same as if the Ordinance contained no illegal or void provisions.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its final passage and publication as by law provided.
