**SUBJ:** Third reading of ordinance for establishing a new speed limit on county road.

**DATE:** March 29, 2012

Third reading of an ordinance to establish a 50 mph speed limit on F58 (200<sup>th</sup> Street) from the west city limits of Walcott to the east city limits of Walcott.

The City of Walcott maintains the south side of F58; the county maintains the north side of F58. This change is being done at the request of the City of Walcott. The Walcott City Council approved the change on their February 20, 2012 meeting.

The original section of F58 belonged to the state of Iowa and was under the jurisdiction of the Iowa DOT. This ordinance will include the section that was previously established by the state at 50 mph.

AN ORDINANCE TO AMEND CHAPTER 13-34 OF THE SCOTT COUNTY CODE  
RELATIVE TO DESIGNATED SPEED LIMITS ON SCOTT COUNTY SECONDARY  
ROADS.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Add to Sec. 13-340, Add Item No. 4 to read:

O. Walcott

4. 50 MPH - On F58 from the West Walcott city limits  
through the east Walcott city limits.

SECTION 2.

The County Auditor is directed to keep and maintain a copy  
of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason  
illegal or void, then the lawful provisions of this  
Ordinance shall be and remain in full force and effect, the  
same as if the Ordinance contained no illegal or void  
provisions.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with the  
provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its  
final passage and publication as by law provided.
