
Re: A request by Jeffrey Reed for approval of the Final Plat of Oak Valley Addition, an eight (8) lot residential subdivision located in part of the SW ¼ of Section 15, Buffalo Township, east of Coonhunters Rd and north of 113th Street.

The Planning Commission unanimously recommended approval of the Final Plat in accordance with staff's recommendation with the condition that covenants be submitted outlining the ownership and maintenance of the proposed subdivision outlots. The applicant has submitted those covenants and the other required platted documents to allow the Final Plat to be approved and recorded.

The Final Plat for this property was originally submitted for review on December 10, 2010. It was reviewed and recommended for approval by the Planning Commission on January 4, 2011. The recommendation for approval was with the condition that surety be posted for the uncompleted road improvements to the access driveway (113th Street) prior to Final Plat approval by the Board of Supervisors.

Scott County Subdivision Regulations require a Final Plat be submitted to the Board of Supervisors within 60 days of the Planning Commission's recommendation or the Planning Commission's recommendation expires. On March 17, 2011 the Board of Supervisors granted a six month extension to the 60 day time limit for Final Plat approval. The applicant did not submit the required materials within that six month extension and the Board of Supervisors denied the Final Plat without prejudice on September 29, 2011.

The applicant resubmitted the Preliminary Plat for reapproval by the Planning Commission. The Board of Supervisors approved the resubmitted Preliminary Plat in accordance with the Planning Commission's recommendation on March 15, 2012.
