Resolution approving the contract for HMA Surfacing and Paved Shoulder on Y68 from Wapsipinicon River North .41 miles (L-213) and 150<sup>th</sup> Av from 290<sup>th</sup> St North to 305<sup>th</sup> Street (L-311) to the low bidder of Determann Asphalt Paving, Camanche IA in the amount of \$430,933.80.

Bids were as follows:

The FY 12-13 budget amount for this project was \$500,000.00. The engineer's estimated cost was \$489,522.67. The actual cost is 12% less than estimated amount.
