Subj: Approval of award of bid – Jail roof replacement

As you know, we have been working with Larrison and Associates to prepare specifications and solicit bids to replace the roof and make some repairs to stone and soffit metal work for the two older sections of the Jail building. The bid deadline for the project was July 3, 2012 at 2:00pm. Below summarizes the bids we received:

Contractor	Total Bid Amount
Beckwith Commercial Roofing	\$249,234.00
Frye Builders	\$329,700.00
Renaissance Restoration	\$314,900.00
Precision Builders	\$458,000.00
Jim Geise Commercial Roofing	\$618,266.00
Sterling Commercial Roofing	\$339,360.00

We have met with the apparent low bidder and reviewed the scope of work, conditions, project approach and schedule. They assure us and the project architect that they have accounted for the full scope of work and are prepared to complete the project in a thorough, quality and expedient manner. We will be meeting with the Sheriff's Office before the project commences to coordinate security and logisitics for the project.

Since the project is under budget, we have asked the low bidder to submit a proposal for some additional façade work on the north and east sides of the oldest part of the building. We do not expect that work to exceed an additional \$25,000. That additional work would come to the Board for consideration as change requests at a future Board meeting.

I recommend that the Board of Supervisors accept the bids and award this project to the low bidder, Beckwith Commercial Roofing in the initial total amount of \$249,234.00. This project is budgeted in the Capital Improvements Plan in the amount of \$400,000.
