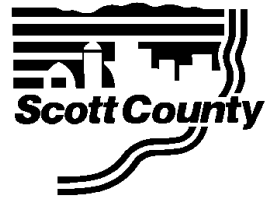

The Purchasing Division has solicited bids for the replacement of one mini-van vehicle for the Sheriff's Office. This vehicle is for use as a transport van for the Jail Division. Below summarizes the bids we received for the requested vehicle:
