Resolution approving the purchase of Sewer Jetter and Brush Chipper. Bids received for the equipment were as follows:

**JETTER**

Sewer Equipment of America Chadwick IL	\$49,500.00
John Bean Jettters Ankeny IA	\$51,900.00

I recommend the Board of Supervisors approve the low bid of \$49,500.00 from Sewer Equipment Co. of America for the sewer jetter.

**CHIPPER**

Midwest Underground Supply LLC Omaha NE	\$23,900.00
Vermeer Sales & Service Pella IA	\$27,500.00

I recommend to the Board of Supervisors approve the low bid of \$23,900.00 from Midwest Underground Supply for the brush chipper.

Our new equipment budget is \$750,000.00. The purchase of these two pieces of equipment brings our total for the 2013 budget to \$579,028.00, leaving a balance of \$170,972.00. We have a pick up truck left to purchase for this year.
