SUBJ: Third reading of ordinance for establishing two new yield signs on county road.

DATE: October 24, 2013

Third reading of an ordinance to establish two yield signs in Parkview.

- a) From the West entrance at the intersection of Park Avenue Court and Park Lane Circle.
- b) From the East entrance at the intersection of Park Avenue South and Park Lane Circle.

The Parkview Homeowners Board requested that we place stop signs at this location. My response was that we would do a traffic study to determine if stop signs were warranted. We looked at Traffic volume, Speed limits, and sight distance which are the major factors in determining justification for regulatory signs. We also did a "live" observation during the peak times to determine turning patterns and peak volumes. Our study showed that the warrants for stop signs were not met but the location did meet warrants for yield signs. The primary focus here is to create a safer environment at this location. Yield signs should adequately alert the driver to slow down and watch for oncoming traffic.

Resolution to approve the Agreements between Scott County and IA DOT for HMA Resurfacing on Z16 from F45 to F33 and 270th St from Scott County Park to Utica Ridge Road (Z16).

These are federally funded projects. The preliminary estimate for both projects is \$3,800,000.00. Eighty percent of the project (\$3,040,000.00) will be funded from Federal Highway funds, and twenty percent (\$760,000.00) will be from our Farm to Market funds.

The letting is scheduled for February 2014 and construction should take place the summer of 2014. This will be a crack and seat project with asphalt overlay. We will increase the width of the pavement from 22 feet to 24 feet and add a four foot paved shoulder as well. This project is very similar to what we did with stimulus money on Y-48 near West Lake Park.

Re: Recognition of Scott County Beautification Foundation Board and others for the Welcome to Scott County signs.

In October 2010, Mr Michael Giudici, on behalf of the Scott County Beautification Foundation came to the Board of Supervisors to propose a plan to install "Welcome to Scott County" signs at various locations where travelers enter Scott County. He did not request any funding from Scott County but stated that the funds would be raised privately. Rather he asked for the Board to endorse the project and allow the signs to be placed in appropriate locations.

In May, 2011 the Beatification Board released an RFP for sign design and Allen Sign Company was chosen to design and fabricate the signs. The design was presented to the Board of Supervisors for its input before the Foundation Board settled on the final design. The chosen design was for similar signs of two sizes, the smaller being a natural limestone sign to be placed along two lane roads with slower speed limits, the second larger sign would be fabricated from a heavy duty plastic but would appear as natural stone. These larger signs would be placed on 4 lane roads with higher speed limits.

The Beatification Board has taken a go slow approach, both due to limited funds but also to be sure that each sign is properly placed and landscaped. The first two signs were installed last year, with a large sign on the Y-40 overpass over US 61 in Blue Grass and the second was a smaller sign on old Hwy 6 in Durant's City Park. A third sign has just been installed this summer on the 305th Street overpass of Hwy 61 just south of the Wapsi River.

Most recently the Blue Grass sign has been landscaped with natural limestone and perennial & evergreen plants. The individuals and others that have worked on this project and/or made financial contributions are:

Re: Update on Greater Davenport Redevelopment Corporation and the Eastern Iowa

Industrial Center.

Since its inception in 1997, Scott County has been a partner in the Greater Davenport Redevelopment Corporation (GDRC) with the City of Davenport, Mid American Energy, and the Davenport Chamber. Those four entities incorporated the GDRC to own and market the Eastern Iowa Industrial Center (EIIC) in northwest Davenport. The City of Davenport and Mid American Energy (Dakota Dunes) made the initial investment to purchase and develop the original 203 acre industrial park. The \$1.5M invested by Dakota Dunes and \$890K of the City of Davenport's total investment of \$1.5M were to be repaid on a per acre formula as land was sold. Additional revenue from the sale of any land was to be used for operating expenses of the GDRC and to purchase additional land. Over the years to facilitate further development of the park an additional 152 acres have been purchased. The GDRC has had 12 land sales over 13 years, totally 151 acres; leaving a balance of 204 acres owned by the GDRC. Total proceeds of those sales have been \$4.9M.

The Quad Cities Chamber of Commerce had previously provided administrative, sales and marketing support for the industrial park. Previously the GDRC had paid for those services with both a line of credit and income from the sale of land. A number of years ago the GDRC requested each of the participating entities, to make an unsecured loan to cover \$300,000 of operating expenses. The City of Davenport and Scott County each approved loans to GDRC of \$100,000 at an interest rate of 4% on a one year note. Mid-American Energy and DavenportOne were to split the balance of the \$300,000, 75%-25%. In 2007 those loans were modified to stop accruing interest and the existing interest and principal were combined and that balance is being paid off on a per acre formula as the balance of the industrial land is sold. Two years ago the GDRC hired an executive director to work part time marketing and managing the park; while and the QC Chamber continues to provide financial management and space for the executive director for a fee.

From FY2006 until FY 2013 the City of Davenport and Scott County have made annual contributions to the GDRC for its marketing budget. The City's contribution had been \$85,000 and the County's contribution had been \$30,000 up until the past year when the City reduced its contribution to \$56,678 in FY13. The County still contributed \$30K in FY13, however the City has not included any funding for the GDRC in its FY14. In the meantime, without more land sales the GDRC is funding its budget with deferred repayments it held in reserve from previous land sales.

I will prepare a full presentation summarizing land sales, debt schedule, and marketing budget for the GDRC for the October 22^{nd} Committee of the Whole meeting.

Subj: Approval of award of bid for Administrative Center HVAC controls

The electronic system that controls the heating and cooling system in the Administrative Center is in need of some replacements. While all of the individual thermostats and controllers for individual rooms/spaces were replaced when the building was renovated from 1999-2003, the main controller/computers that help the system communicate and allow technicians to make adjustments to all the different equipment were not replaced at that time. We knew that eventually this electronic equipment would become unserviceable and require replacement.

We solicited quotes to replace that equipment and have bids from two vendors. We limited those quotes to those from existing controls systems that we currently have in our facilities to avoid introducing additional, different systems. Those quotes are:

Vendor	Amount
Trane Company	\$321,300.00
Baker Group	\$37,600.00

The quote from the Trane Company is much higher because their system would require the replacement of individual controllers and thermostats throughout the building. The quote from Baker Group is for the main controllers/computers only.

We recommend that the Board of Supervisors award this bid to the Baker Group in the above amount. It is budgeted in the Capital Budget in the current fiscal year. I will be available at the next Committee of the Whole meeting to discuss this recommendations and to answer any questions you or the Board may have.

Subject: Insurance Recommendations

Health/Pharmaceutical

We have received a proposal to renew our Administrative Service Agreement with United Health Care for three years. The first year has a 3% increase, with no increase in the second year and a cap of a 5% increase in the final year. Part of this consideration is their desire to move us to the national platform of United Health Care rather than the local River Valley platform. I have attached the comparison of the two platforms for your information

As part of our coverage with UHCRV we annually renew our Specific Stop Loss and Aggregate Stop Loss coverage. This year with the platform change the coverage will be through UHC. Last year we increased our specific deductible to \$150,000, we are not recommending any additional changes. Jeff Scarpinato, Holmes Murphy, was able to negotiate no increase in the Specific Stop Loss should we go to the national platform. If we stay on the local platform we were looking at a 5.7% increase and additional cost of \$15,732. There is a 4.3% increase in the Aggregate Stop Loss coverage for a total cost of \$1,473.

Dental

Last year we entered into a 2 year administrative services agreement which resulted in a 2% increase this year. The trend in lowa is 4%.

Vision

We are in the going into the second year of a two year agreement with Avesis for vision coverage. Thus there are no rate changes.

Health Care Rates

The County has reviewed our health care rates with our actuarial, Silverstone Group and Holmes Murphy and both have recommended slight increase to the employee premium rates for CY14. The recommended increase is 2.5% which results in an employee family premium increase of \$4.24 a month.
