I recommend that the Board of Supervisors approve the purchase of the track loader from Bob Cat of the QC in the amount of \$35,708.23 and approve the purchase of the roller from Altorfer Cat in the amount of \$27,500.00.

You will notice that I have recommended the purchase of the Bob Cat Skid steer which is slightly higher in price. The reasons for this is that we are trading a 2007 Bobcat T-190 Skid Steer so our staff is accustomed to the controls of the Bob Cat and our attachments will work with this new machine. We also have a few parts in stock that will work with the new machine and the new Bob Cat is significantly quieter than the other models which will require less hearing protection for our employees. For the roller we are trading a 1986 Mauldin Roller.

Our new equipment budget for 2014 is \$693,000 but I have decided to not purchase a Motorgrader and not to purchase a single axle dump truck. This gives us an opportunity to focus on these two smaller pieces of equipment and still save over \$300,000.
