Subj: Approval of purchase of squad car replacements for the Sheriff's Office

Facility & Support Services, at the request of the Sheriff, solicited bids for six 2014 Utility Police Interceptor Ford Explorer SUV vehicles. These vehicles will replace patrol units currently in service as they reach the end of their life cycle.

Below summarizes the bids we received for the six units:
