Resolution approving the purchase of precast Portland cement concrete beams for construction of a 55' by 30' bridge over Big Elkhorn Creek in Section 30 of Cleona Township, in Scott County, Iowa. The following quotes were received:

Oden Enterprises, Inc. out of Wahoo, NE: \$78,771.80

Cretex Concrete Products out of Maple Grove, MN: \$69,500.00

Alternate bid for a 55' by 30' bridge:

Cretex Concrete Products out of Maple Grove, MN: \$71,400.00

We have chosen the 55' bridge because of the additional benefits in the backwater calculations. The lower backwater elevation will help to prevent road overtopping that occurs occasionally with the existing bridge. We felt that the added benefit of the longer bridge justified the additional \$1,900 cost. This is a joint Day Labor project with all costs to be split equally with Cedar County. The current bridge has a three ton posting and needs to be replaced before winter. This project is in the FY2015 Construction Program and Budgeted at \$90,000
