Re: Approval of the request of Gateway Development Group, Nahant Marsh Education Center, and Mount Olive Church of God in Christ for the transfer of various County tax deed properties.

The County Board held a public hearing on the four requests we received to transfer various tax deed properties from four non-profit organizations. Prior to the public hearing, Scott Tunicliff from Hilltop Campus Village notified the Board they were withdrawing their request to acquire the County Tax Deed property G0043-44A located on Harrison Street adjacent to 704 Harrison Street. That property will therefore be included in the upcoming public auction of tax deed properties

Jack Haberman from the Gateway Development Group addressed the Board on the GDG's efforts to stabilize and preserve the heritage of the neighborhood and why they had submitted a request for G0054-20 located at 517 Ripley Street. There is a deteriorated single family residence on the property that dates from the 19th century. Haberman stated, at the public hearing, that they intend to restore this house, as they have done with other homes in the neighborhood.

Nahant Marsh Education Center has submitted a request for seven (7) tax deed parcels that are strips of former rail road right of way that all lie adjacent to the current active rail line but that were apparently abandoned by the rail road over 20 years ago. The County took tax deed to these strips of land in 1994 and has held them ever since. Recently staff visited with Brian Ritter the Executive Director of Nahant Marsh to see if they would be interested in acquiring them. Nahant Marsh has other land in the area adjacent to the railroad and has permission from the railroad to use their right of way to access these properties for whatever minimal maintenance they would require.

Finally, a representative from Mount Olive Church of God in Christ at 1020 Ripley Street spoke on the church's plans to stay and expand at their current location. In order to expand the church needs additional land which is why they had submitted a request for two (2) tax deed parcels in the vicinity of the church. One is located across the alley from the church at 422 West 10th Street and the other at 326 West 10th Street. Staff sees this church as a stabilizing influence in this neighborhood and believes as such their request for these two properties meets County policy.

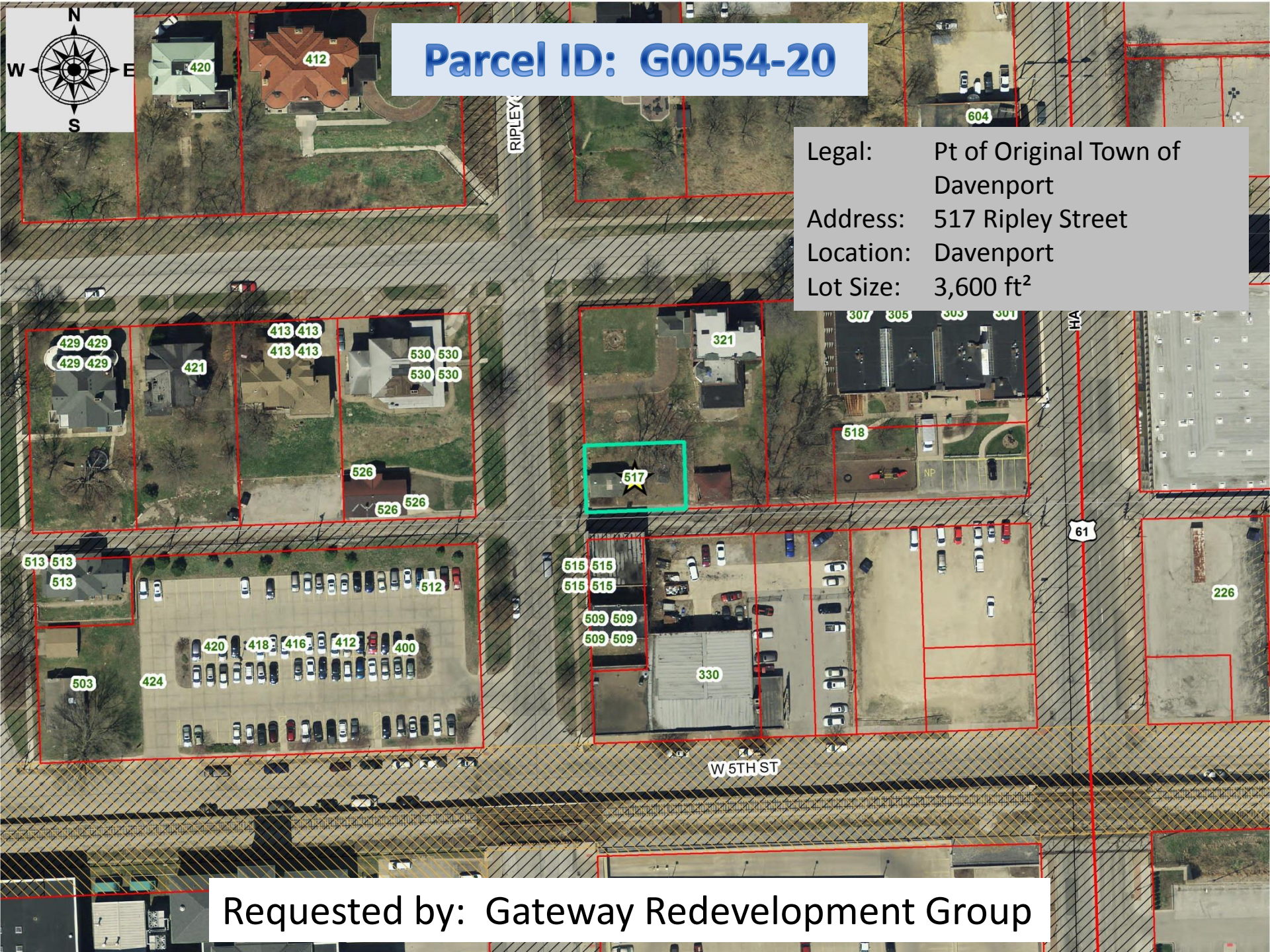

The required time for the prior owners of the property to redeem the property by paying the back taxes due has expired. County policy on the disposal of tax deed properties states that a community based non profit agency can request transfer of such properties if they can show how those properties will benefit a community program or serve a public good. The property then may be transferred to the non profit agency if the Board of Supervisors determines such transfers are in the best interest of County residents. All these properties are located in the City of Davenport and all back taxes, interest and special assessments have been previously abated on these property.

Staff would recommend approval of these three requests on the basis that they comply with County policy. Staff has prepared separate resolutions approving these requests for the Board's consideration.

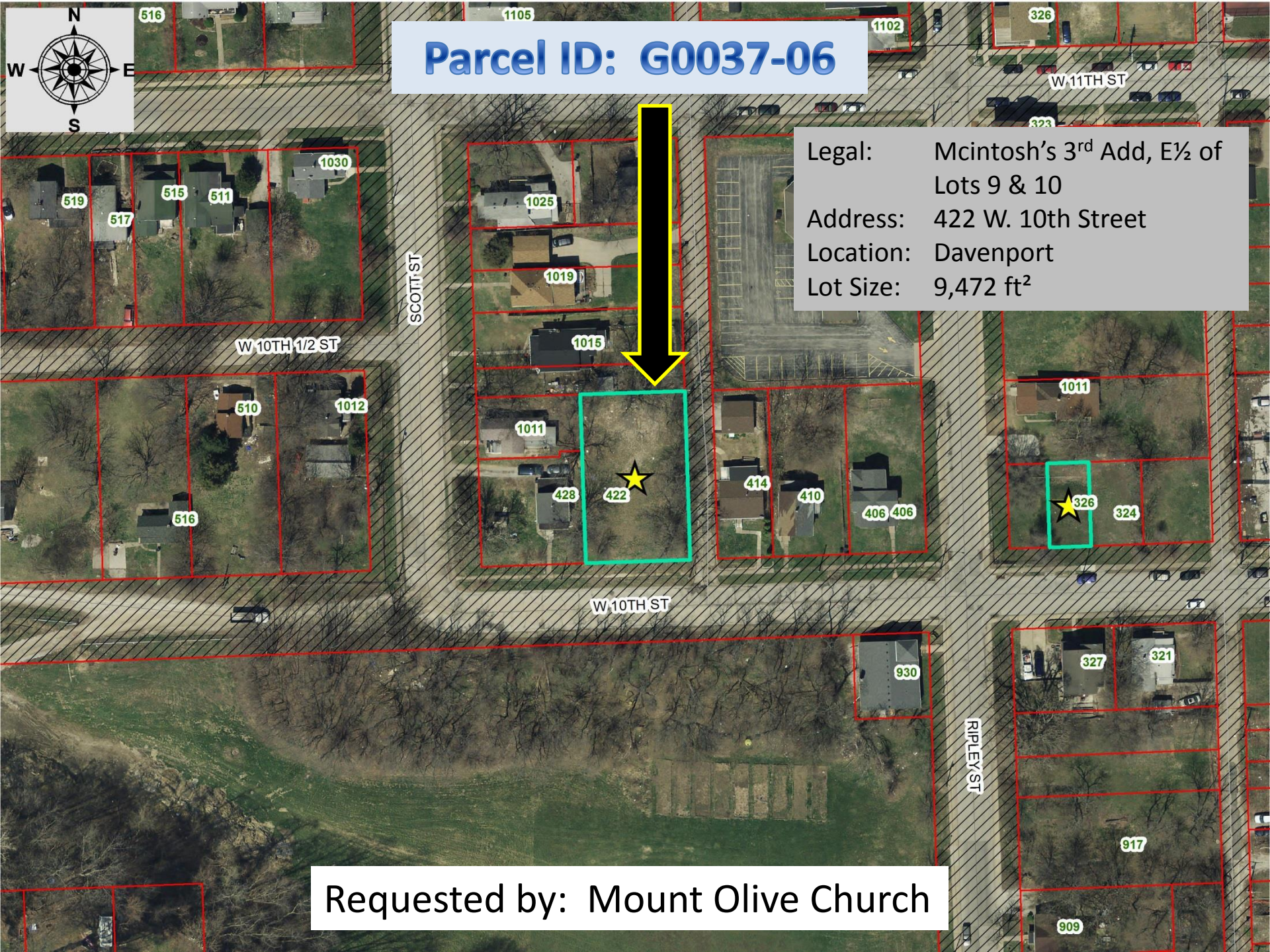

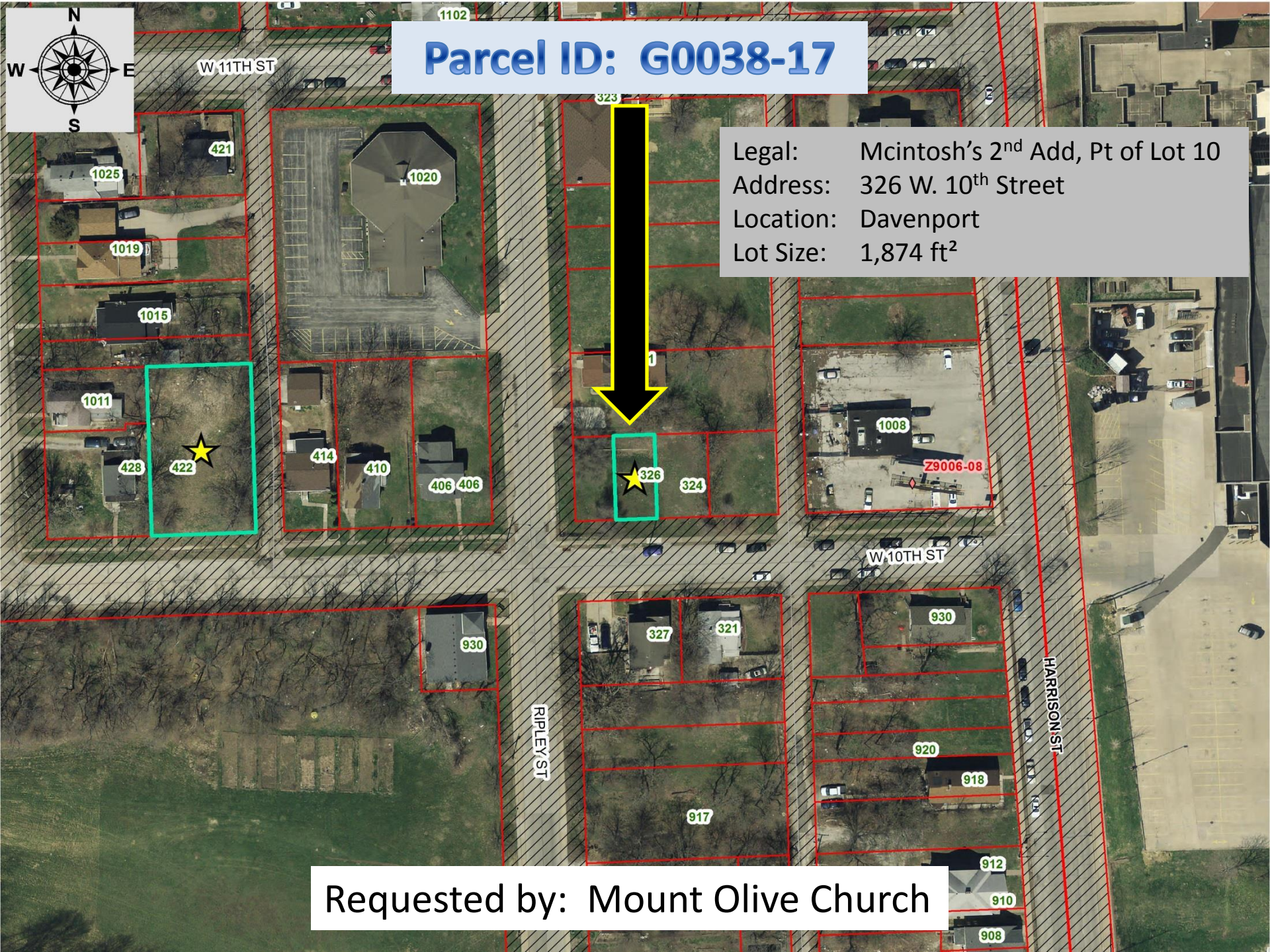

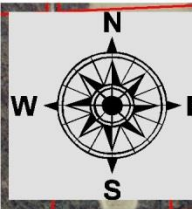

Subject: Settlement of Bailiff Collective Bargaining Agreement

We were able to negotiate a three year agreement with the IBEW (i.e. Bailiffs). The economic package includes a 2.25% general wage for FY16; 2% for FY17 and 2.25% for FY18. Additionally they will begin receiving overtime after 8 hours in a day and a \$50 increase in their uniform allowance. In return they have agreed to phase in some of the desired changes to the Health Lifestyle programs so that spouses will be tested in the future.

The Scott County Board of Health held a public hearing on June 18, 2015, for amending Chapter 23 entitled “Private Sewage Disposal Systems” and Chapter 24 entitled “Non-Public Water Supply Wells.” After receiving no public or written comments, fee changes were approved by the Board of Health.

The following list includes existing fees, new fees, and justification for the fee changes. For the Water Well Program Reconstruction Permit, you will see a decrease for the permit fee from \$95.00 to \$15.00. The reason for the proposed decrease is that staff had conversations with other Health Departments throughout the state and most are charging a minimal or no fee for the permit. If the Department charges \$95.00 for the permit and then reimburses the homeowner for rehabilitating the well through the Grants to Counties Program, the incentive to rehabilitate the well is less. We want to get wells that do not meet code rehabilitated.

AN ORDINANCE TO AMEND CHAPTER 23, OF THE SCOTT COUNTY CODE RELATIVE TO
ONSITE WASTEWATER TREATMENT AND DISPOSAL SYSTEMS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

The following is a summary of the substantive changes:

Under Sec. 23-6, A. FEES, change items 1, 2, and 5 to read:

1. \$220.00 for a permit to construct a private sewage disposal system.
2. \$100.00 for a permit to install or replace pipes, septic tanks or distribution box.
5. \$85.00 for a septic tank abandonment permit.

AN ORDINANCE TO AMEND CHAPTER 24, OF THE SCOTT COUNTY CODE RELATIVE TO NONPUBLIC WATER SUPPLY WELLS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Under Sec. 24-5, A. FEES, change items No. 1, 2, and 4 to read:

1. \$280.00 for a Permit to construct a waterwell.
2. \$150.00 for driven (sandpoint) water well permit.
4. \$15.00 for reconstruction, rehabilitation, or installation of liner.

SECTION 2.

The County Auditor is directed to keep and maintain a copy of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason illegal or void, then the lawful provisions of this Ordinance shall be and remain in full force and effect, the same as if the Ordinance contained no illegal or void provisions.

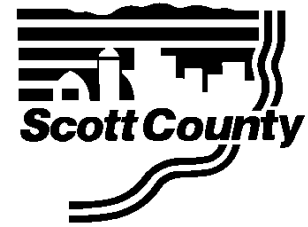

RE: Mental Health Advocate Position

The Mental Health Advocate is a position which is currently under the direction of the Chief Judge of the District. According to HF468 passed during the recent legislative session, effective July 1, 2015, the Boards of Supervisors of each county will be responsible for the appointment of the Advocate. The current Mental Health Advocate, Rose McVay, will be “grandfathered” into her current position according to HF468. Rose currently serves as the advocate for our mental health region, Cedar, Clinton, Jackson, Muscatine and Scott County, under a 28E agreement.

At the May Eastern Iowa Mental Health Regional Governing Board meeting, members expressed an interest in continuing to operate under a 28E agreement that way the advocate would continue to serve all five counties. There needed to be a decision made by each county on which county would serve as the employer of record as of July 1, 2015. All four county Boards of Supervisors agreed that Scott County should serve as the employer of record. A new 28E agreement will follow.

The Management Team (CPCs) developed a list of job duties and background requisites. Scott County HR department developed the attached job description for approval. The Mental Health Advocate is appointed by the court to serve as an advocate for an individual under a 229 mental health commitment order. The advocate provides support throughout the legal proceedings and follows up with the individual to ensure treatment is being followed and their rights are being upheld. There is some travel and reporting requirements of this position. The position requires a Bachelor’s degree.

The Mental Health Advocate would be a position under the Community Services Department and supervised by the director of the department. The resolution establishes the pay level and adds it to Scott County’s Table of Organization. We would like to fill this position as soon as possible. I will be available at the Committee of the Whole to discuss the new job description and answer any additional questions.

Job Summary

Under general supervision, serves as Mental Health Advocate for Scott, Cedar, Clinton, Jackson and Muscatine counties in compliance with Iowa Code Chapter 229. Represents the interest of clients involuntarily hospitalized by the Court. Provides support to clients throughout proceedings and follow up treatments.

Relationships

Reports to: Community Services Director

Supervises: N/A

Works with: Outside agencies/facilities, Community Services staff, other County departments, medical and mental health professionals, legal staff, and the Court system.

Physical/Environmental Conditions

Primarily works in an indoor office environment. Frequent travel to other facilities inside and outside Scott County.

Major Duties/Performance Measures:

1. Makes contact and communicates with client within five (5) days of their commitment. Visits client within fifteen (15) days of the commitment and periodically thereafter.

2. Collaborates with the Court, Coordinators of Disability Services within the region, and service providers; advises the Court if the services of an attorney are needed to safeguard the client's interest. Ensures compliance with the requirements of Section 229.19 of the Iowa Code.
3. Attends hospitalization hearings and subsequent hearings as needed. Travels to hospitals and facilities for periodic client visits.
4. Acts as spokesperson for the client and assist in communication with medical personnel as necessary. Review client's medical records and reports submitted to the court.
5. Develops and maintains written reports and documentation of client's progress. Prepare and file quarterly reports with the Court on the actions taken with each client and the amount of time spent.
6. Ensures data is kept in compliance with all federal, state, and local confidentiality requirements including HIPAA.
7. Attends meetings, conferences and/or seminars as required.
8. Performs other job-related duties as assigned.

Bachelor's degree in social science, education, nursing or related area.

Work Experience:

Three (3) years of work experience in a mental health treatment related position.

Essential Skills:

SUBJECT: 2014/2015 JAG Grant Application

The Scott County Attorney's Office submitted a grant on or before June 26, 2015 to the Edward Byrne Memorial Justice Assistance Grant (JAG) Program FY 2015 Local Solicitation. Scott County is eligible for \$79,809 which is a joint allocation between Scott County, Bettendorf and Davenport.

This grant supports the Hotel/Motel Interdiction unit (HIDE) of the Quad City Metropolitan Enforcement Group (QCMEG) providing drug trafficking enforcement in the Quad Cities. Officers assigned to the HIDE are a combination from the Bettendorf and Davenport Police Department and the Scott County Sheriff's Department. Currently, the Davenport Police Department does not have an officer assigned. Each agency submits documentation of officer's salaries, benefits and partial overtime to the County for reimbursement. The County submits quarterly and annual reports to the Office of Justice Programs.

The Scott County Attorney's Office serves as the multi-agency fiscal officer. JAG awards are based on a formula between population and reported crime statistics.

The grant requires notification to the governing body, Board of Supervisors, in a public format as well as a Memorandum of Understanding for the joint application which is signed by an authorized representative from each jurisdiction. This is to ensure that only one application is submitted. If the grant is denied, then the application will be withdrawn.

Upon your resolution to accept the applicable award from JAG, the Scott County Attorney's Office will continue with the grant management process.
