- SUBJ: Third reading of ordinance for establishing speed limits on county roads.
- DATE: August 27, 2015

This is the third reading of an ordinance reducing the speed limit on 270th St. The current speed limit on the north, westbound, county section changes from 30 mph to 40 mph and then to 45 mph at the city limits.

The City of Long Grove has requested that we change the 40 mph section to 30 mph. The city is in the process of changing the south, eastbound, section to 30 mph. We will reduce the 40 mph speed limit to 30 mph from the current 30 mph speed zone westerly to the city limits (approximately 600').

We recommend changing the speed limit from 40 mph to 30 mph to be in compliance with the City of Long Grove's request.

SCOTT COUNTY ORDINANCE NO 2015-_____

AN ORDINANCE TO AMEND CHAPTER 13-34N OF THE SCOTT COUNTY CODE RELATIVE TO DESIGNATED SPEED LIMITS ON SCOTT COUNTY SECONDARY ROADS.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA:

SECTION 1.

Under Sec. 13-34N, Add Item No. 5 to read:

Extend the 30 MPH speed limit - On 270th Street north side, westbound lane to the Long Grove city limits.

SECTION 2.

The County Auditor is directed to keep and maintain a copy of the Ordinance in the County Auditor's office.

SECTION 3. SEVERABILITY CLAUSE

If any of the provisions of the Ordinance are for any reason illegal or void, then the lawful provisions of this Ordinance shall be and remain in full force and effect,

The same as if the Ordinance contained no illegal or void provisions.

SECTION 4. REPEALER

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 5. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its final passage and publication as by law provided.

As you are aware, Wold Architects and Engineers was selected to complete the design process for the Courthouse First Floor Phase 3 & 4 Project. This project has multiple aspects including:

- Completing the south half of first floor including three ADA compliant courtrooms, creating Judges Chambers, jury rooms, court reporter offices, and court support staff offices.
- Replacement of the video courtroom technology
- Courthouse main electrical switch replacement
- Relocating the County data server room and updating the air handler that serves the space
- Creating a new reception window for the County Attorney's office which will correct an outstanding issue with ADA compliance
- Adding two new offices in the second floor County Attorney's Office
- Replacing exterior windows in the Courthouse

Wold has completed plans and specifications for this project, and will be at the August 25th Committee of the Whole meeting for a presentation of the project to the Board.

The project requires a public hearing and the plans and specifications require Board approval. I am recommending that the board set the public hearing for August 27, 2015 at 5:00 p.m. with approval of the plans and specifications also on the agenda that same night.

This project consists of several budgeted projects in the FY16 and FY17 Capital Improvement Plan including CH ADA Improvement Project, Computer Room Air Handler Project, CH Electrical Switch Replacement Project, CH Egress Project, CH Window Replacement Project, and CH Phase 3 & 4 Project the total the amount of \$4,045.000.00. Current Project Estimate is \$4,040,000.00
