

SUBJ: Discussion about IRVM Plan and Steering Committee Appointments

DATE: January 10, 2017

As you know, Scott County approved and implemented an Integrated Roadside Vegetation Management Plan (IRVM) in June of 2016. Under the plan, a steering committee is appointed by the Board of Supervisors to provide input and guidance to the County Engineer and if approved, the Roadside Manager. According to the approved plan:

"The committee shall consist of no more than ten persons and be comprised of no more than five persons representing the public sector (federal, state, and local) and no more than five persons representing the private sector. Committee members should possess a background in native vegetation, weed management, environmental sciences, conservation, and agriculture or have a demonstrated interest in one of the stated areas and/or roadside management. The members shall serve three-year staggered terms. Terms shall be on a calendar year basis."

The original Committee having not been appointed by the Board has served as a task force to develop the plan and begin implementation of the plan. The Secondary Roads Department has several yearly resolutions that are done in January. The Steering Committee appointments will be added to these every year. The makeup of the Steering Committee will need to be gender balanced. The following individuals have been suggested and are willing to serve.

Re: Notice of Opportunity to Consult on proposed amendments to the City of Davenports North Urban Renewal Area new TIF project.

The City of Davenport has notified Scott County of an Opportunity to Consult be held on Wednesday January 4, 2017 at 8:30 AM. The City is proposing the following amendment to the Urban Renewal Area and project Plan for the Eastern Iowa Industrial Center.

- 1) **Identification of new area:** The 160 acres east of the Kraft Heinz facility, south or Slopertown Road and west of Division Street currently owned or optioned by the GDRC.
- 2) **Identification of Project**: Sterilite plastic container manufacturing company to develop 2.5M sq.ft. on the property and create 500 jobs over five years.
- 3) **TIF incentive proposed**: Rebate of 60% of the TIF payments generated for a total of \$8.361M.
- 4) **TIF payments proposed for land and infrastructure**: \$9.5M of TIF generated to be used by the City of Davenport for land acquisition and infrastructure costs for the project.

Scott County TIF Review Committee has submitted the following questions on Davenport TIF proposal for Sterilite facility in the EIIC

- 1. The rebate of the 60% of the TIF generated, how is that calculated and over what time frame?
- 2. The \$9.5M for land and infrastructure. Is that about coming off the total TIF generated or is it taken out first and then the company gets 60% of the remaining?
- 3. What is the nature and projected cost of the infrastructure?

- 4. Does this agreement require the creation of 500 jobs over five years? What are the provisions if it doesn't meet these goals?
- 5. What types and pay scale of jobs are expected to be created by this development?
- 6. Are there any more details you can share with the Scott County Board now that the project has been announced publically?




Scott County Board of Supervisors/Scott County Civil Service Commission/ County Administrator:

I would like to propose a restructuring of the ranks within the Sheriff's Office, to commence at the beginning of my term, to allow for two Chief Deputy appointments and three Deputy Sheriff's at the rank of Lieutenant. This restructuring would increase the current number of Chief Deputies from one to two and would reduce the number of Lieutenants from four down to three.

The Code of Iowa allows for three Chief Deputies for Scott County based on the population. The past practice for Scott County is to have either two Chief Deputies or to have one Chief Deputy and one civilian Jail Administrator. I do not plan to add a civilian Jail Administrator.

This request will likely require an amendment to the current Sheriff's Office budget moving funds from patrol salaries to administrative salaries and approval from the Civil Service Commission. I would like to propose at this time that this request be placed on the agenda.


Chief Deputy over Jail administrator Anderson over Clearman


