This resolution is to approve the construction contract for Bridge Replacement Project BROS-C082(57)--8J-82 on 85th Avenue over a Tributary to Hickory Creek in Allens Grove Township. The existing bridge is a 120' x 20' three-span steel I-beam bridge with a concrete deck on wooden abutments and concrete piers that was built in 1938. The bridge is presently posted for reduced loading due to a structurally deficient substructure.

This project is included in our FY2017 and FY2018 budget. The Engineer's Estimate of Costs for this project is \$459,180.34. The following bids were received:

Taylor Construction, Inc. New Vienna, IA	\$645,766.10
Muscatine Bridge Co., Inc. Muscatine, IA	\$545,211.11
Brandt Construction Co. Milan, IL	\$529,149.30
Jim Schroeder Construction, Inc. Bellevue, IA	\$496,825.30 **

The low bid is within 10% of the Engineer's Estimate of Costs. I recommend acceptance of the low bid from Jim Schroeder Construction, Inc.
