Subj: Approval of plans and specifications- Pedestrian Walkway & Parking Lot Improvement Project

As you are aware, the Architectural firm of Bracke.Hayes.Miller.Mahon was selected to complete the design process for the project listed above. This project creates visual cues to drivers on Western that people may be crossing from drive to drive, creates the pedestrian ADA walkway across the courthouse parking lot, replaces the current light fixtures with LED fixtures to match the Administrative Center, reorients parking in the Courthouse lot to a more logical arrangement, implements work to divert water away from the delivery ramp at the back of the Juvenile Detention Center, adds some new campus signage and includes overlay of both the Courthouse and Administrative Center parking lots.

Mark Miller of BHMM will be at the May 2, 2017 Committee of the Whole for a presentation of the project and to answer any questions the Board may have. The project will be out to bid on April 25, 2017 with bids due back on May 18, 2017.

This project requires a public hearing to allow for comments on the plans and specifications; I recommend that the Board set that public hearing for May 4, 2017 at 5:00 p.m. Approval of the plans and specifications will follow on the agenda that same evening.

This project is budgeted in the Capital Improvement Plan FY17 and FY18 in the total the amount of \$675,000, which includes all aspects of the project.

I will be in attendance at the next Committee of the Whole to discuss this project and answer any questions you or the Board may have.
