In August of 2019, the State of Iowa was awarded \$33,442,000 through the Federal Highway Administration Competitive Highway Bridge Program (CHBP) grant to replace 77 bridges. Scott County was awarded a portion of this federal funding to be used toward the cost of replacing four structurally deficient bridges.

Project No. BRS-CHBP-C082(60)--GB-82 (9 Cleona) is an existing 100' X 28' Concrete Slab Bridge built in 1968 on Y30 (20th Avenue) over Mud Creek in Liberty Township. Location #4 on the attached map.

Project No. BRS-CHBP-C082(61)--GB-82 (6 Blue Grass) is an existing Twin 12' Span Concrete Slab Culvert on Concrete Sheet Piles built in 1957 on F58 (200th Street) over a Tributary to Mud Creek in Blue Grass Township. Location #3 on the attached map.

Project No. BRS-CHBP-C082(62)--GB-82 (7F Princeton) is an existing 42'-6 X 28' Steel I-Beam Bridge built in 1967 on Z30 (240th Avenue) over Lost Creek in Princeton Township. Location #2 on the attached map.


Project No. BRS-CHBP-C082(63)--GB-82 (33H Liberty) is an existing 24' X 28' Concrete Slab Bridge built in 1962 on Y30 (20th Avenue) over a Tributary to Mud Creek in Liberty Township. Location #1 on the attached map.

This resolution is to modify the funding amounts and sources shown in our County Five Year Program in regards to the four bridge replacement projects. When these projects were programmed, we did not know if we would receive the grant or how much federal funding we would receive.

It has been determined that we will receive federal funding at 55% of the estimated project cost at the time of submittal of the application. The remaining cost of the projects will be paid from our County Highway Bridge Program Fund managed by the Iowa Department of Transportation.

Re: Discussion of request from the City of Long Grove to enter into a 28E Agreement with Scott County for the Scott County Planning and Development Department to issue building permits and provide building inspection services for the City of Long Grove.

The City of Long Grove has submitted a request for Scott County to enter into a 28E agreement for the County to provide building inspection services for the City of Long Grove. This would be similar to the existing agreements with the cities of Dixon, Donahue, McCausland, Panorama Park, Riverdale and LeClaire. Scott County has had such agreements with these cities for over 25 to 35 years. The agreement with Donahue and Riverdale includes floodplain management. Overall these agreements have worked exceedingly well. The cities have received excellent building inspection services at no cost to the City and the County's cost have been offset by permit revenue. Historically, building permit fees for both the 28E cities and the rural areas have paid for the County's building inspection program.

The way the 28E agreements work is just as Scott County adopts the International Building Code by reference, the cities adopt the County Construction Code by reference. Then Planning and Development issues the building permits and conducts the building inspections for those construction projects. Technically it is the city's code that is being enforced. The County does not charge the cities any fee for this service but retains all permit fees paid for by the property owner for their building permits. The city is still responsible for enforcing its zoning codes and we require city approval of the site plan for any permit that expands the "footprint" of buildings on the property to ensure they meet city zoning setbacks and are for a permitted use. The City of LeClaire also must approve any Certificate of Occupancy for compliance with other City requirements before the C.O. is issued.

Similar to Scott County and other Quad Cities jurisdictions, Long Grove had also adopted the current edition of the IBC and contracted with an individual for building inspection services. Long Grove's population is 868 according to the most recent US Census estimate. Census records indicate there were 287 single-family homes in 2010. There is some commercial zoned land in the city also but it is mostly single family residential. Staff would anticipate that there could be 25 to 50 permits issued annually with perhaps fewer than 10 of those for new houses. This could represent a three to six percent increase in the department building inspection workload. Significant amounts of the department's current inspection activity is in the Winfield/Butler Township area which includes Park View. The increase would also be offset by the payment of permit fees which the County would collect for all permits issued. The City would be responsible for any enforcement action required for violations.

In the meantime, the Council discussed and approved contracting building code inspections to Scott County through a 28E agreement for a term of 6 months, with the potential to renew the contract for a longer term if necessary. Mayor Limberg called the Long Grove City Council Meeting to order at 7:00pm at City Hall. Roll Call: Present: Cronise, Drumm, Cook, Blinkinsop; Absent: Herrin. The agenda was approved on a motion by Blinkinsop, seconded by Drumm, all ayes, motion carries. Cronise motioned to approve the consent agenda, seconded by Cook, all ayes, motion carries. The Mayor welcomed guests.

With written and verbal consent of the City Attorney, Cobie, Blinkinsop motioned to enter into a closed session to discuss the sale of public property at 104 S First St., seconded by Cook, all ayes, motion carries. The motion was approved on a roll call vote of Ayes: Blinkinsop, Cronise, Drumm, & Cook; Absent: Herrin. Cronise motioned to return to open session, seconded by Drumm, all ayes, motion carries.

A Public Hearing took place regarding the sale of City property located at 104 S. First Street to Joseph Zrostlik LC for a purchase price of \$75,000. With no public comments, Cronise motioned to close the Public Hearing, seconded by Drumm, all ayes, motion carries. Drumm motioned to read Resolution 2019-16 Sale of City Property, seconded by Blinkinsop, all ayes, motion carries. Resolution 2019-16 was approved with a roll call vote of Ayes: Blinkinsop, Drumm, Cronise, & Cook; Absent: Herrin. The Council briefly discussed and agreed to consider the creation of a Long Grove historical preservation ordinance. Based on a Committee of the Whole recommendation, and with input from the Public Works.

ordinance. Based on a Committee of the Whole recommendation, and with input from the Public Works Director, Saladino, Cronise motioned to approve the posting of a full time Assistant Public Works position, potential candidates to be reviewed monthly, and to contract out 6 months to Scott County for building code inspections. The motion was seconded by Blinkinsop, all ayes, motion carries.

Cook motioned to approve the Committee of the Whole recommendation to not allow homeowners to fill in road side ditches unless they agree to obtain prior approval and pay for city engineer review. The Mayor provided a brief City Hall maintenance update. The Clerk informed the Council that T-Mobile accepted the Council's counter offer for \$700 with no other changes to the contracts original timeline. The City Attorney, Cobie, requested the contract include written clarification from T-Mobile regarding the timeline terms of the contract, to be considered at next month's Council meeting.

Cook motioned to approve the E-billing software contract with an initial install cost of \$400.00 and a reoccurring annual maintenance fee of \$300.00, seconded by Cronise, all ayes, motion carries. Cook motioned to approve the Clerk's attendance to the Iowa League's Budget Workshop, seconded by Blinkinsop, all ayes, motion carries. The Clerk presented the Council with an updated FY19 Financial Report. The Council requested Saladino investigate dump truck hoist maintenance costs. Saladino presented the Council with an IAMU safety representative contract. The Council requested an IAMU representative provide a presentation to the Council.

The Mayor reported the following November 4th events: City Hall Open House 11:00am to 12:00pm, North Prairie Park Playground Ribbon Cutting Ceremony, 5:00pm to 6:00pm, and the City Hall Ribbon Cutting Ceremony/2nd Open House, 6:00pm to 7:00pm. The Mayor opened the meeting to public comments, and with no public comments, closed public comments. Cook motioned to adjourn, seconded by Drumm, all ayes, motion carries.

28E Agreement between Scott County and the City of Long Grove

This agreement is by and between the City of Long Grove, Iowa and the Scott County Board of Supervisors in accordance with Chapter 28E.12, <u>Iowa Code 2019</u>. This agreement shall remain in effect indefinitely, unless and until a sixty (60) day advanced notice is provided in writing by either party to the other indicating an intent to cancel.

- **Section 1.** The City Council of Long Grove, Iowa considers it to be in the best interest Of the residents of Long Grove if the Long Grove Code of Ordinances, Chapter 150 Building Code is administered by the Scott County Planning and Development Department, a department of the Scott County Board of Supervisors.
- **Section 2.** The City Council of Long Grove, Iowa hereby delegates the duties and responsibilities of the above mentioned regulations to the Scott County Department of Planning and Development, except for the legal enforcement of any and all provisions of the regulations, which is reserved as follows: The City of Long Grove, Iowa will undertake full responsibility to initiate any necessary legal action against violators or to enforce requirements through the office of the Long Grove City Attorney.
- **Section 3.** The City of Long Grove shall hold harmless from and indemnify Scott County Board of Supervisors, Scott County, its officers, employees and other agents, from and against all claims, suits, actions, costs, attorney fees, expenses, damages, judgements or decrees, incurred or arising out of any accident, claim or other occurrence as a result of providing the services herein described by Scott County.

Scott County shall hold harmless from and indemnify, the City of Long Grove, \cdot the Long Grove City Council, its officers, employees and other agents, from and against all claims, suits, actions, costs, attorney fees, expenses, damages, judgements or decrees, incurred or arising out of any accident, claim or other occurrence as a result of providing the services herein described to the City of Long Grove.

- **Section 4.** The Scott County Board of Supervisors agrees to enter into this agreement with the City of Long Grove. The Board authorizes the Planning and Development Department to establish an administrative system of building code inspection and enforcement within the City of Long Grove, Iowa to carry out the purposes of this agreement, during the term of the agreement. The Director of Planning and Development shall assume the following duties and responsibilities:
 - 1. To receive and process building permit applications at the office of Scott County Planning and Development;
 - 2. To inspect construction and work authorized by said permits and as required by Long Grove City Ordinances in a timely and professional manner;
 - 3. To collect and retain all fees received as required by Long Grove City Ordinances;
 - 4. To provide personnel at the office of Scott County Planning and Development to answer questions regarding building codes and building permits;
 - 5. To maintain records of building permits at the office of Scott County Planning and Development;
 - 6. To notify permit holders of violations and all required corrective actions;

- 7. To summarize all building permits issued in the City of Long Grove and provide a report for the City Council from time to time as requested; and
- 8. To accomplish any other duties normally associated with administering building codes which is not inconsistent with other provisions of this Agreement or local, State or Federal law.
- **Section 5.** In consideration for the work performed under this agreement the Scott County Department of Planning and Development shall retain all building permit fees collected.
- **Section 6.** Amendments to this agreement may only be made by the approval of both parties in the manner prescribed by law.
- **Section 7.** The parties hereto after approval of appropriate resolutions, have caused this agreement to be executed by duly authorized officials as of the dates indicated. This agreement shall take effect when signed by both parties.

WHEREAS, the proposed creation of the statistical boundaries will provide the opportunity for marketing and in investment opportunities which could lead to job creation and economic growth for Scott County, Iowa;

NOW, THEREFORE, BE IT RESOLVED by the Scott County Board of Supervisors as follows:

Section 1. That Scott County Board of Supervisors supports the port boundary creation of the Mississippi River Ports of Eastern Iowa and Western Illinois between Mississippi River mile 461.5 and river mile 583.0 to include the entire riverfront of Scott County from river mile 469.7 to river mile 506.8 on the Mississippi River. Said support extends for statistical purposes only and not to any waterways organization or further control of the Mississippi River nor does the port designation impact any existing or future public port, terminal, or economic development authorities.

Recognizing November as Diabetes Awareness Month

WHEREAS, diabetes is growing at an epidemic rate worldwide affecting more than 422 million people. The International Diabetes Federation (IDF) estimates by 2040 there will be more than 642 million people living with the disease. The United States ranks #3 out of 10 in diabetes diagnoses; and

WHEREAS, diabetes is growing at an epidemic rate in the United States. According to the Centers for Disease Control and Prevention (CDC), nearly 31.2 million Americans have diabetes and face its devastating complications. What's true nationwide is also true in Iowa; and

WHEREAS, according to the American Diabetes Association, diabetes affects approximately 286,000 people in Iowa—10.8% of the population, and is a serious disease for which there is no known cure and which is the seventh leading cause of death by disease in the United States; and

WHEREAS, according to the American Diabetes Association, approximately 75,000 people in Iowa have diabetes but do not know they have the disease and may experience damage to the heart, eyes, kidneys, and limbs greatly increasing their health risk; and

WHEREAS, according to the American Diabetes Association, another 810,000 people in Iowa, 35.2% of the adult population have prediabetes, a condition which puts them at greater risk for developing Type 2 diabetes, and if current trends continue, 1 in 3 American adults will have diabetes by 2050; and

WHEREAS, diabetes has many faces, affecting everyone, young and old alike—Caucasians, African Americans, Latinos, Native Americans, Asian Americans, and Pacific Islanders, with minority populations in the United States having an increased risk for developing the disease; and

WHEREAS, an increase in community awareness of risk factors and symptoms related to diabetes can improve the likelihood that people with diabetes will get the attention they need before suffering the devastating complications of the disease;

NOW, THEREFORE, BE IT RESOLVED by the Scott County Board of Supervisors as follows:

Section 1. That we hereby proclaim November 2019 as Diabetes Awareness Month in Scott County, Iowa, and encourage all citizens to help fight this disease and its deadly complications, including heart and kidney disease, stroke, blindness, and amputation, by increasing awareness of the risk factors for diabetes, and by providing support to those suffering from diabetes.
