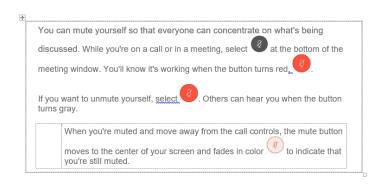





As you will recall, on November 9, I presented an Offer and Acceptance for purchase of property located at 936 W 4th Street, commonly known as Burke Dry Cleaners.

One of the terms of that agreement allowed the "County access to this property ahead of closing to perform Environmental Due Diligence consisting of a Phase 1 and Phase 2 Environmental Site Assessment and corresponding reports. In the event that Due Diligence reveals that there is an environmental condition that is unacceptable to the County, the County can terminate the Purchase Agreement and any of its obligations thereunder."

Based on findings of the environmental testing, which indicated a reportable level of tetrachloroethene (perch - dry cleaner solvent) in groundwater and a visible presence of petroleum product, Scott County notified the owner, through our attorney, that the County was exercising our option to terminate the purchase agreement.

Mahesh:

Based on the comments of several of the Board Members after the presentations from Wold, and the looming deadline for the implementation of the new law requiring juveniles currently held in the adult jail be moved to Juvenile Detention we discussed internally how to best keep the project moving forward.

Due to Wold Architects and Engineers' integral role in the project to date and a tight timeline, we reached out to them to request a proposal for remaining architectural, engineering, and construction administration services.

Scott County and Wold have completed several successful projects together including SECC, Sheriff Patrol, Courthouse Courtroom Renovations, Clerk's Office Renovations, Juvenile Detention East Side Expansion, the Administrative Center Window Replacement and Exterior Project, and most recently we are working on the Scott County Attorney's Office Renovation.

Wold prosed a fixed fee for remaining service based on the following information:

Scope of Work and Approach to Establishing a Fixed Fee

The scope of work is based on the November 23, 2021 schematic design presentation. Wold is proposing a fixed fee using the same formula as they did for the schematic design. For the remainder of the work they calculate this fee to be based on approximately 36,230 GSF which includes both the Youth Justice and Rehabilitation Center and the attached Assessment Center with a total

estimated project budget of approximately \$21,750,000.00, which was determined as follows:

Construction Cost (includes a 5%	\$17,370,000.00
design contingency	
Construction Contingency (5%)	\$ 800,000.00

TOTAL ESTIMATED PROJECT COST	\$21,750,000.00

Utilizing a fee percentage of 6.5% the fee for this project would be \$1,129,050.00. Wold will credit their fee for work performed to date, resulting in a credit of \$131,980.00. The fixed fee for this project will be the remaining \$997,070 plus actual reimbursable expenses which is standard per contract.

This type of pricing is typical for the professional services requested.

Proposed Schedule

If the Board decides to move forward with Wold for these additional services, they anticipate the schedule for design development through construction documents to take approximately 8 months, meaning that this project would be out for bid in August 2022.

Based on their familiarity with the JDAAC work process and recommendations, the scope of the project, their previous performance on Scott County Projects, and the ability to keep the project moving forward without delay, it is my recommendation that the Board award a contract to Wold Architects and Engineers for Design Development and Construction Administration in the amount of \$997,070.00 plus actual reimbursable expenses.

David Farmer and I will be available at the next Committee of the Whole to discuss the recommendation and answer any questions you or the Board may have.

Resolution Regarding the Confidentiality of Public Records Related to the Election Infrastructure of Scott County

BE IT RESOLVED BY the Scott County Board of Supervisors as follows:

WHEREAS, under Iowa law, sensitive vulnerability information is subject to examination by the public unless it is classified as a confidential public record, and Iowa Code, Chapter 22, subsection 7, paragraph 50 identifies confidential public records as:

Information concerning security procedures or emergency preparedness information developed and maintained by a government body for the protection of governmental employees, visitors to the government body, persons in the care, custody, or under the control of the government body, or property under the jurisdiction of the government body, if disclosure could reasonably be expected to jeopardize such employees, visitors, persons, or property.

- a. Such information includes but is not limited to information directly related to vulnerability assessments; information contained in records relating to security measures such as security and response plans, security codes and combinations, passwords, restricted area passes, keys, and security or response procedures; emergency response protocols; and information contained in records that if disclosed would significantly increase the vulnerability of critical physical systems or infrastructures of a government body to attack.
- b. This subsection shall only apply to information held by a government body that has adopted a rule or policy identifying the specific records or class of records to which this subsection applies and which is contained in such a record; and

WHEREAS, Iowa Administrative Rule 721-22.50(52) requires each county to maintain a written security policy which shall include detailed plans to protect election equipment and data from unauthorized access as well as describe methods to be used to preserve the integrity of the election and document the election process; and

WHEREAS, the nature of the information contained in the required written security policy qualifies it as a confidential record as identified by Iowa Code 22.7(50) as outlined above; and

WHEREAS, threats to election infrastructure through breaches of cybersecurity may be initiated by any number of sources including, but not limited to hackers, disgruntled current or former employees, criminal enterprises, terrorists, and foreign governments; and

WHEREAS, while the Scott County Auditor's Office advocates for 100 percent transparency in local government, the Office recognizes that releasing public records related to vulnerabilities of election infrastructure would be irresponsible and detrimental to the voters and may allow bad actors to affect the integrity of elections administered by the County.

NOW, THEREFORE BE IT RESOLVED, that the Scott County Board of Supervisors, a government body defined in Iowa Code Chapter 22, section 1, paragraph 1, hereby designates as a matter of public policy that any public records related to Scott County's Elections Security Policy and the protection, security measures, response plans, emergency preparedness, security codes, combinations, passwords, restricted physical area passes, keys, audio/video systems, emergency response protocols, vulnerabilities, and any information contained in records that if disclosed would significantly increase the vulnerability of the election infrastructure shall remain confidential public records.

FURTHER BE IT RESOLVED, that this resolution is effective upon the date of approval by the Scott County Board of Supervisors.


