Mahesh:

As you know, we have changed the scope of work that was part of the Wold YJRC Contract. We have added COOP/COG space on a second level to the YJRC building.

This change provides a change in core electrical and mechanical systems to accommodate the additional space, larger YJRC lobby, stairs, and an elevator. On the second floor this includes restrooms, break room space and shelled out space that can be used as multipurpose space in this condition, but fully developed in future fiscal years as needed.

The proposed fixed fee aligns with the fee method for the YJRC contract and is based on estimated construction cost (plus 5% design contingency). For this work that the estimated cost of additional construction is \$4,320,000.00 x 6.5%.

The additional Wold fee would be \$280,000.00 plus actual reimbursable expenses.

This fee is calculated as follows:

SD (Schematic Design) = 15% = \$ 42,120

DD (Design Development) = 20% = \$ 56,160

CD (Construction Documents) = 40% = \$112,320

Bid = 5% = \$ 14,040

CA (Construction Administration) = 20% = \$ 56,160*

* (only applicable if the bid alternate is awarded)
