Re: Purchase of Handheld Portable Intraoral Imaging System and Associated Software

The Health Department recently received a budget amendment of \$18,563.00 of federal funds from the Iowa Department of Health to our current I-Smile™ Silver contract. The amendment is for the purchase of a KaVo NOMAD Pro2 handheld, rechargeable, battery-powered portable intraoral imaging system, carrying case, and DEXIS Software Starter Bundle. This equipment will provide the ability for our I-Smile™ Silver and I-Smile™ staff to complete intraoral images in the field (nursing homes, senior living areas, child care centers, community events, etc.) and use the results in care coordination efforts with local oral health providers and in educational presentations. The DEXIS Software is web-based and is a common software utilized by local dental offices which will allow for ease of sharing images.

The Scott County Health Department received three bids from current vendors that could provide this specialized equipment and software.

Henry Schein® Dental: Melville, New York	\$17,439.00
KaVo Kerr: Charlotte, North Carolina	\$19,695.00
Patterson Dental Supply, Inc.: St. Paul, Minnesota	\$18,132.34

The Health Department has reviewed all three bids, and recommends that the Board approve and award the bid to Henry Schein® Dental: Melville, New York in the amount of \$17,439.00. This expense will be fully grant funded; the spending authority will be added to the budget as part of the spring budget amendment as the grant contract amendment was approved by the Iowa Department of Public Health after the deadline for the first budget amendment.
