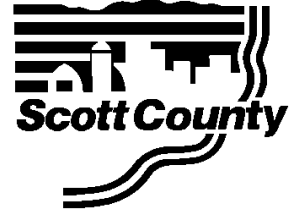

Re: Assessment of election costs for City/School Elections 2021

Date: March 29, 2022

My office has submitted a resolution to approve the assessment of election costs for the 2021 City/School elections, including the November 2, 2021 City/School Election and the 7th Ward Primary Election for Davenport, in the amount of \$132,195.71.

Iowa Code §47.3 defines allowable costs: "costs shall include but not be limited to the printing of the ballots and the election register, publication of notices, printing of declaration of eligibility affidavits, compensation for precinct election boards, canvass materials, and the preparation and installation of voting equipment. The county commissioner of elections shall certify to the county board of supervisors a statement of costs for an election."

The attached resolution covers all allowed costs and is a fair distribution of these costs among the various jurisdictions.

I plan to attend the March 29th Committee of the Whole meeting and would be happy to answer your questions.
