
This resolution is to approve a contract for two bridge replacement projects that are tied together. The first bridge replacement project is located on Z-30 (Wells Ferry Road), over Spencer Creek, in Section 6 of Pleasant Valley Township (just south of the I-80 overpass). The second bridge replacement project is located on Z-30 (Wells Ferry Road), over Spencer Creek, in Section 8 of Pleasant Valley Township, approximately 0.2 miles north of Valley Drive.

The tied projects were let by the Iowa Department of Transportation (Iowa DOT) on March 19, 2024. The bids received were as follows:

Helm Group, Inc., D/B/A Helm Civil	\$1,893,033.31
Jim Schroeder Construction, Inc.	\$1,915,885.28
Brandt Construction Co. & Subsidiary	\$2,238,862.40
General Constructors Inc. of the Quad Cities	\$2,385,293.30
Godbersen-Smith Construction Co. & Subsid.	\$2,596,253.85
Taylor Construction, Inc.	\$2,814,451.95

The low bid for these projects is less than our engineering estimate of \$2,128,961.50. Scott County was awarded \$600,000 of Community Project Federal Funding from a grant application submitted through the office of Congresswoman Miller-Meeks and \$652,500 of Surface Transportation Block Grant Program federal funding through the Bi-State Regional Commission Metropolitan Planning Organization to be used toward construction costs for these two bridge replacement projects. Construction costs will be paid by the Iowa DOT out of our Highway Bridge Program and Farm-to-Market accounts with reimbursement of federal-aid funding through the two grants.

These projects are programmed in FY2024 of our Five-Year Construction Program and will be constructed during the 2024 calendar year construction season. I recommend entering into a contract with Helm Group, Inc. D/B/A Helm Civil contingent on the unit prices listed in the contract. The Iowa DOT now processes contracts electronically with digital signatures. As part of the resolution to award the contract, I request approval to sign the contract electronically on behalf of the Board of Supervisors. Included with this memo is a project location map.

Dear Vanessa,

The County Attorney's Office will be losing a long-time employee to retirement on July 5th. Sally Marten is currently one of two Senior Victim Witness Specialists. She has held that position since 1998, the other specialist has been with the County for approximately a year and a half. This position requires some special training, therefore the request to overfill is essential. The attorneys rely on the specialists to assist them with victims from the start of the case through disposition.

The Senior Victim Witness Specialists coordinate with the Scott County Attorneys, Clerk of Court, Family Resources, Law Enforcement, Iowa Legal Aid, and Monsoon (culturally specific organization) frequently. The Specialists answer all victim walk-in questions, provide case updates, and keep in contact with parties through victim letters, victim packets and subpoenas.

The Senior Victim Witness Specialist is an AFSCME position. Sally is currently at Step 13. The new hire will come in at a Step 1 which is a significant cost savings.

In order to take full advantage of Sally's institutional knowledge, we are requesting that we over-fill her replacement with a start date somewhere between May 28th and no later than June 12, 2024, to allow for proper training of the unique processes required. This will still be a short amount of time for training. Sally is taking two separate weeks of vacation. One week in June and the first week in July, which is her last week of employment, so the extra training time will be extremely helpful in working toward a smooth transition moving forward on July 8th.

Review of Organizational Change requests

The following reclassification requests were submitted organizational changes as part of the budget process for Fiscal Year 2025:

- Platroom Specialist (Auditor's Office) (+0 FTE)
- Administrative Coordinator (Conservation) (+0 FTE)
- Facility Maintenance Manager (FSS) (+0 FTE)
- Senior Building Inspector (Planning and Development) (+0 FTE)
- Senior Engineering Technician (Secondary Roads) (+0 FTE)
- Parts and Inventory Clerk (Secondary Roads) (+0 FTE)
- Lead Multi-Service Clerk (Treasurer's Office) (+0 FTE)

These organizational changes are existing positions that the department is requesting a change in FTEs for Fiscal Year 2025:

- Custodian (FSS) (+2.0 FTE)
- Senior Facility Maintenance Worker (FSS) (+1.0 FTE)
- Detention Youth Counselor (YJRC) (+5.0 FTE)

The additions below are requests for new classifications for the respective department for Fsical Year 2025:

- Senior Office Assistant (IT) (+1.0 FTE)
- Administrative Assistant (YJRC) (+1.0 FTE)

Discussion

We are still within the parameters of the extensive compensation and classification study approved in 2019, thus there are few positions that have significantly changed since that time warranting reclassification. Market changes were not reviewed for specific classifications and considerations for future review will need to be evaluated with potential economic impacts in mind. The requests submitted demonstrated significant changes in duties. These requests were required to complete a Position Analysis Questionnaire (PAQ) and were submitted to Public Sector Personnel Consultants (PSPC) for review and analysis. PSPC reviewed relevant internal and external comparable jobs and any market factors related to the position. PSPC then made a recommendation to Human Resources on where to place or slot the position in the Pay Plan.

Changes to the table of organization or budgetary requests are merely increasing or decreasing the number of positions organizationally and did not require review by PSPC. For departments requesting a change in FTE level, departments submitted information regarding the business necessity for the change in FTE level for consideration by the Board. In order to determine the appropriateness of the request the factors considered are increased volume of work, greater efficiencies, and change in key personnel.

There are two requests for new positions. The first is for a Senior Office Assistant for the IT Department and the second for an Administrative Assistant for YJRC. A PAQ was completed for both positions and PSPC reviewed relevant internal and external data. A recommendation was then made to Human Resources for Pay Plan placement.

Reclassification Requests

Platroom Specialist (Auditor's Office) (+0 FTE)

The Auditor submitted a reclassification to address the additional responsibilities given to the position since the 2019 study and job description update. These include more indepth knowledge and ability to interpret information utilized in legal descriptions and land surveying. The current pay range is 19 and the recommended pay range based on PSPC's review is 21.

Administrative Coordinator (Conservation) (+0 FTE)

A reclassification was requested for the Senior Administrative Assistant classification in the department to address new responsibilities gained by the role when there was a major upgrade to the recreation software utilized by the department. The program is used for in-person and on-line concessions/POS transactions, activity registrations, and inventory control. The position is the subject matter expert in the department for the software and is responsible for the setup/configuration, administration, and training for department users. These additional technical duties and skill set were not addressed in the Senior Administrative Assistant classification. An updated title was created for the reclassification. The current pay range for the Senior Administrative Assistant is 23 and after PSPC reviewed the duties elaborated in the PAQ and internal comparables, the recommendation is for the Administrative Coordinator to be placed at a pay range 24.

Facility Maintenance Manager (FSS) (+0 FTE)

FSS has increased locations recently including the warehouse, several MEDIC facilities, and the yet to be completed Youth Justice and Rehabilitation building. Increased workload for the department necessitates some shifting of duties. Additional responsibilities tasked to the Facility Maintenance Manager classification include administrative functions, project management for capital projects including construction and renovation efforts, preparing specifications, RFPs, service contracts and professional agreements. After considering the additional duties and review of the PAQ with PSPC, it was recommended the position be reclassified. The current pay range is 27 and recommendation is placement at pay range 30.

Senior Building Inspector (Planning and Development) (+0 FTE)

The Board of Supervisors approved Planning and Development's FY24 request to create a new Senior Building Inspector classification that would require four (4) certifications/licenses during the last budget cycle. At that time, no current Inspector met the requirements to reclassify to a Senior Building Inspector. It is anticipated the requirements will be met by July 1, 2024. The department will then have 1 Senior Building Inspector and 1 Building Inspector.

Senior Engineering Technician (Secondary Roads) (+0 FTE)

The Board of Supervisors approved creation of the Senior Engineering Technician classification in 2019 to allow for a promotional opportunity once an Engineering Technician achieves the National Bridge Inspection Standard Certification and meet the qualification of a team leader pursuant to 23 CFR 650.309(b) and the Iowa Department of Transportation requirements. Both of the current Engineering Technicians have secured the certification and we are requesting the incumbents move to the Senior Engineering Technician classification.

Parts and Inventory Clerk (Secondary Roads) (+0 FTE)

The County Engineer submitted a reclassification request for the Parts and Inventory Clerk classification to account for additional tasks assigned to the role including coordinating the uniform, floor mat, towel, first aid, and safety supply ordering and distribution process, preparing invoices for services performed on non-Secondary Roads assets and providing information to applicable department for repairs on damaged

vehicles/equipment. The current pay range is 18R and based on review from PSPC and internal comparability, pay range 20R is recommended.

Lead Multi-Service Clerk (Treasurer's Office) (+0 FTE)

During the last several years, recruitment has been a difficult task for all departments, including the Treasurer's Office. In the past 3 years, there have been 17 new hires for the office, which in previous years would have 1-3 hires annually. The training of new clerks is largely tasked to the Motor Vehicle Supervisor and County General Store Manager and with onboarding of new employees happening consistently, the Motor Vehicle Supervisor and County General Store Manager have been unable to devote the time needed to oversee the development of their staff as a whole. Feedback from exiting employees has indicated the duties are more complex than they anticipated and we believe a more dedicated training regimen will aid in the onboarding and assessment process for new hires. Reclassifying a current Multi-Service Clerk into a new classification of Lead Multi-Service Clerk will assist management in having a dedicated individual be the go-to individual for new employees learning their new job. This role will also assist management for training needs that may arise with existing employees who may experience difficulties with certain tasks or processes. The current pay range for Multi-Service Clerk is 17. the PAQ was reviewed with PSPC and based on internal comparability, a pay range 18 is recommended.

Budgetary Requests

Custodian (FSS) (+2.0 FTE)

With the addition of MEDIC as a county department, FSS will be providing custodial services for 6 MEDIC locations (Genesis West, Genesis East, Iossi, Blue Grass, Eldridge, and LeClaire) totaling 30,720 square feet of space. Current distribution is about 12,000 square feet per employee. Based on the calculation, we are asking for 2 additional FTE. This will increase the FTE to 12.0 in the classification.

<u>Senior Facility Maintenance Worker (FSS) (+1.0 FTE)</u>

With the addition of MEDIC as a county department, FSS maintenance staff will be providing maintenance services at the 3 new County owned locations (Genesis East, Eldridge, and LeClaire) which totals approximately 22,000 square feet. One additional Senior Facility Maintenance Worker is being requested to cover the maintenance needs of the 3 additional locations. In addition, additional staffing will allow implementation of preventative maintenance programs for the new buildings and therefore lessen dependence on, and costs related to contracted service providers. Additionally, another 30,000 square feet of warehouse will be gained when the current tenant vacates the space which is anticipated on July 1. This will increase the FTE to 7.0.

Senior Office Assistant (IT) (+1.0 FTE)

The IT Director is requesting a Senior Office Assistant to assume clerical duties such as accounts payable, miscellaneous billing, revenue collections, contract and vendor management and other general office tasks. Previously, some of these duties were performed by Desktop Support Technicians. Establishing a dedicated clerical role will help the department be more efficient and allow the Desktop Support Technicians to focus on supporting end users with their technical needs. This will result in 1.0 FTE in the classification.

Detention Youth Counselor (YJRC) (+5.0 FTE)

With the addition of the new Youth Justice and Rehabilitation Center (YJRC) facility, the Director is requesting 5 full-time positions. The state mandated staff to resident ratio is 1:5 during waking hours and 1 staff per sleeping unit overnight. The most recent population data shows the average daily number in FY23 of the facility was 16 youth with peaks as high as 26. In order to accommodate peak population levels, an additional 5 full-time positions are requested to staff 25 beds at all times. By adding additional staff, we can ensure that the center is operating within state mandated ratios. It is anticipated there will be 5 staff members working during waking hours (first and second shift) and 3 staff working overnight. The additional staff will also allow for the center to partner with other juvenile facilities who may need to house at our center (at an established rate). The anticipated hiring of the additional staff will be dependent on when the new facility is completed. This will increase the FTE to 21.3.

Administrative Assistant (YJRC) (+1.0 FTE)

The Director is requesting an Administrative Assistant classification to perform administrative tasks such as accounts payable, revenue collections, miscellaneous billing, and purchasing card requisitions. The position will also have payroll functions, inventory tasks, purchasing of supplies and equipment, and will assist management with grant reporting. Currently these responsibilities are split among the supervisors and with the addition of the new YJRC building, adding an administrative role will allow the supervisors to focus on the programs and operations of the center. This will result in 1.0 FTE in the classification.

Proposed Action

Several of the positions result in needs for additional equipment that would be addressed through the Capital Budget. The annual costs to the General Fund is \$577,816 as itemized in the attached spreadsheet. If approved these changes are scheduled to take effect July 1, 2024, unless noted otherwise.

- RE: Amendment to 28E Agreement with Clinton County for Interim Medical Examiner Services and Coverage

On February 1, 2024, the Scott County Board of Supervisors approved a 28E agreement for the Scott County Medical Examiner Team (Dr. Harre, Dr. Richard Blunk, and Dr. William Jerome) to provide Medical Examiner coverage to Clinton County following a temporary leave of absence by Clinton County's Medical Examiner.

The current agreement is set to expire on March 31, 2024. Unfortunately, the process for the Clinton County Medical Examiner to return to full duties is taking longer than anticipated. Clinton County is meeting with an individual about assuming the role of Deputy Medical Examiner, but that process, training, and state approval will take time. Clinton County has requested an extension to the 28E through December 31, 2024. The date aligns with the end of current appointments for the Scott County Medical Examiner Team. Clinton County does not anticipate needing support for another nine months, but this date prevents repeated amendments. Dr. Harre is in support of this amendment.

The attached amendment was drafted and reviewed by the Clinton and Scott County Attorney Offices.

I ask that the amendment be placed on Board of Supervisors Committee of the Whole Agenda on March 26, 2024 for approval on March 28, 2024.

MEDIC EMS of Scott County acquired existing cardiac monitors that are around 9 years old. In our industry, the typical replacement for these devices is between 5 and 7 years. MEDIC EMS (a non-profit) planned to replace these cardiac monitors in fiscal year 2025, and I have proposed this replacement in the upcoming capital plan.

ZOLL Medical Corporation announced they will increase prices beginning April 1, 2024. I have not received an official price increase, but I heard the increase may be 4-5% on all products, including disposable supplies. I have been working with ZOLL to reduce planned capital expenditures and to avoid the estimated \$50,000 price increase.

I am requesting to move forward with an agreement with ZOLL Medical Corporation to avoid the upcoming price increases. These cardiac monitors will replace the aging cardiac monitor that the existing Paramedics and EMTs currently operate. Replacement with the same monitor will allow a seamless transition to these new monitors and remove any associated costs in purchasing new disposable supplies, cables, chargers, cases, batteries, and clinical training costs. Additionally, the Davenport Fire Department recently purchased these cardiac monitors, allowing a seamless and consistent transition of clinical care between agencies.

These monitors will also enhance our capabilities to facilitate critical care transports of the sickest patients from our local hospital systems to higher levels of care with the critical care transport (CCT) features of these monitors. Currently, we have only four CCT-capable cardiac monitors, and there can be delays in transporting these critical patients due to locating and delivering one of these monitors to the CCT team at the hospital. This purchase will allow us to have a CCT-capable monitor in every ambulance to facilitate the rapid transport of these critical patients.

The attached quote is for purchasing 21 Critical Care Transport-capable cardiac monitors for \$1,013,302.92. We negotiated a five-annual payment plan at a 0% interest rate, with the first payment of \$202,660.59 due on July 31, 2024. This agreement also includes a 27% discount on products outlined in the quote and a five-year service plan, saving us an estimated annual cost of \$50,000 in cardiac monitor repairs and associated service fees. These cardiac monitors will be delivered at the vendor's earliest convenience, and I anticipate the deployment of these monitors in May-June 2024.

Lastly, we were recently notified by ZOLL that the driver safety devices we deploy in our ambulances reached end-of-life on August 1, 2025, with limited support beginning August 1, 2024. These devices facilitate safe driving practices, which in turn reduces the overall annual maintenance cost of our vehicles. In light of this, we negotiated with ZOLL, at no cost, to have eight of these devices included in the quote to be available for on-site replacement in case of failure until our planned capital replacement for Fiscal Year 2026.

Attached is a purchase agreement between MEDIC EMS of Scott County and ZOLL Medical Corporation to replace our cardiac monitors. County Attorney Kristina Lyon has reviewed the contract terms and finds them legally sufficient to meet the intended purposes.

This resolution will allow the Director of MEDIC EMS of Scott County to sign the agreement on behalf of the Scott County Board of Supervisors.



Natural Conservation or Wildlife Areas Property Tax Exemption Instructions, page 3

The exemption may be applied to recreational lakes, forest covers, rivers and stream banks, and open prairies as designated by the board of supervisors of the county in which the property is located.

This exemption is only available to parcels of property of two acres or more. The property must also be utilized for the purposes of providing soil erosion control, wildlife habitat, or both.

An exemption is allowed for rivers and streams or river and stream banks only if the land is located at least 33 feet from the ordinary high water mark of the rivers and streams or river and stream banks.

If the property is an open prairie, the property will be inspected and certified as having adequate ground cover consisting of native species, and that all primary and secondary noxious weeds present are being controlled to prevent the spread of seeds by either wind or water.

If the real property is located within a city, the approval of the governing body must be obtained before the real property is eligible for an exemption.

A property receiving this exemption shall not be used for economic gain of any kind during the assessment year. This includes, but is not limited to, the storage of equipment, machinery, or crops.

If the property is used for economic gain during an assessment year in which it has received this exemption, the property shall lose its exemption and be taxed at the rate levied by the county for the fiscal year beginning in that assessment year.







WHEREAS, the County of Scott, Iowa (hereinafter referred to as the "County"), is a county and political subdivision organized and existing under the laws and the Constitution of the State of Iowa (the "State"), and is authorized and empowered by Chapter 419 of the Code of Iowa, as amended (hereinafter referred to as the "Act"), to issue revenue bonds and loan the proceeds from the sale of said bonds to one or more parties to be used to defray all or a portion of the cost of acquiring, improving and equipping a "project" (as defined in the Act) for the purpose of securing and developing industry and trade within or near the County in order to create jobs and employment opportunities and to improve the welfare of the residents of the County and the State; and

WHEREAS, the County has been requested by Our Lady of Lourdes Church of Bettendorf, Iowa and St. John Vianney Church of Bettendorf, Iowa both of which are whollyowned 501(c)(3) organizations for the Diocese of Davenport (the "Borrowers") to authorize and issue its Private School Facility Revenue Notes (St. Joan of Arc School Project), Series 2024A pursuant to the provisions of the Act for the purpose of (i) financing the construction, improving and equipping of a new 79,990 square foot co-educational, regional Catholic school known as the St. Joan of Arc School located on land located at the Northwest corner of Hopewell Avenue and Criswell Street in Bettendorf, Iowa (altogether, the "School"); (ii) refunding debt previously issued to purchase land where the School will be built; (iii) paying capitalized interest; and (iv) paying costs of issuance (altogether, the "Project"); and

WHEREAS, it is proposed that the County issue not to exceed \$8,400,000 aggregate principal amount of Private School Facility Revenue Notes (St. Joan of Arc School Project), Series 2024A (the "Notes") and loan said amount to the Borrowers under a Loan Agreement among the County, the Borrowers, and Blackhawk Bank & Trust, as purchaser (the "Loan Agreement"), the obligation of which will be sufficient to pay the principal of and interest and redemption premium, if any, on the Notes as and when the same shall become due; and

WHEREAS, notice of a public hearing on a proposal to issue the Notes has been duly given in compliance with Section 147 of the Internal Revenue Code of 1986 and Chapter 419 of the Code of Iowa; and

WHEREAS, a public hearing has been held on the proposal to issue the Notes at the time and place as specified in said notice and all objections or other comments relating to the issuance of the Notes have been heard;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY AS FOLLOWS:

RESOLUTION

RESOLUTION AUTHORIZING THE ISSUANCE, EXECUTION, DELIVERY AND SALE OF PRIVATE SCHOOL FACILITY REVENUE NOTES (ST. JOAN OF ARC SCHOOL PROJECT), SERIES 2024A IN THE AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$8,400,000, OF SCOTT COUNTY, IOWA, THE EXECUTION AND DELIVERY OF A LOAN AGREEMENT AND A BOND PURCHASE AGREEMENT AND OTHER MATTERS RELATING THERETO.

WHEREAS, Scott County, Iowa (hereinafter referred to as the "County"), is a county and political subdivision organized and existing under the laws and the Constitution of the State of Iowa (the "State"), and is authorized and empowered by Chapter 419 of the Code of Iowa, as amended (hereinafter referred to as the "Act"), to issue revenue bonds and loan the proceeds from the sale of said bonds to one or more parties to be used to defray all or a portion of the cost of acquiring, improving and equipping a "project" (as defined in the Act) for the purpose of securing and developing industry and trade within or near the County in order to create jobs and employment opportunities and to improve the welfare of the residents of the County and the State; and

WHEREAS, the County has been requested by Our Lady of Lourdes Church of Bettendorf, Iowa and St. John Vianney Church of Bettendorf, Iowa both of which are whollyowned 501(c)(3) organizations for the Diocese of Davenport (the "Borrowers") to authorize and issue its Private School Facility Revenue Notes (St. Joan of Arc School Project), Series 2024A (the "Notes") pursuant to the provisions of the Act for the purpose of (i) financing the construction, improving and equipping of a new 79,990 square foot co-educational, regional Catholic school known as the St. Joan of Arc School located on land located at the Northwest corner of Hopewell Avenue and Criswell Street in Bettendorf, Iowa (altogether, the "School"); (ii) refunding debt previously issued to purchase land where the School will be built; (iii) paying capitalized interest; and (iv) paying costs of issuance (altogether, the "Project"); and

WHEREAS, a public hearing on the proposal to issue the Notes has previously been held in compliance with Section 147 of the Internal Revenue Code of 1986 and Chapter 419 of the Code of Iowa; and

WHEREAS, the County will loan the proceeds from the sale of the Notes to the Borrowers pursuant to the provisions of a Loan Agreement among the County, the Borrowers and Blackhawk Bank & Trust (the "Bank"), as purchaser (the "Loan Agreement"), pursuant to which the obligations of the Borrowers will be sufficient to pay the principal of and interest and premium, if any, on the Notes as and when the same shall be due; and

WHEREAS, arrangements have been made for the sale of the Notes to the Bank; and

WHEREAS, there have been presented to this meeting the following documents, which the County proposes to enter into:

- 1. The form of Loan Agreement;
- 2. The form of the Notes, as set forth in the Loan Agreement; and
- 3. The form of Bond Purchase Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF SCOTT COUNTY, IOWA, AS FOLLOWS:

<u>Section 1</u>. That the Notes be and the same are hereby authorized and ordered to be issued by the County in accordance with the Loan Agreement. The actual principal amount of the Notes and the maturity dates for the Notes shall be set forth in the Loan Agreement and the interest rate to be borne by the Notes shall be a variable rate as set forth in and subject to the terms and conditions of the Loan Agreement. That the Chairman and County Auditor of the County are hereby authorized and directed to execute and deliver the Notes.

Section 2. That the County loan to the Borrowers the proceeds of the Notes pursuant to the Loan Agreement. The forms of the Loan Agreement and the Bond Purchase Agreement are hereby approved in substantially the same form as submitted to the County, with such final changes as approved by the officers of the County and its Issuer's Counsel. The Chairman and the County Auditor are hereby authorized and directed to execute and acknowledge the Loan Agreement and the Bond Purchase Agreement and affix the seal of the County thereto, which Loan Agreement and Bond Purchase Agreement, with such changes therein as shall be approved by the officers executing such document and its Issuer's Counsel, approval to be conclusively evidenced by the execution thereof.

<u>Section 3</u>. That the sale of the Notes to Bank be and the same is hereby approved and confirmed and the Chairman and the County Auditor are hereby authorized to execute and deliver any appropriate instrument to evidence the sale of the Notes to the Bank.

Section 4. THAT THE NOTES SHALL BE SPECIAL LIMITED OBLIGATIONS OF THE COUNTY. THE PRINCIPAL OF, PREMIUM, IF ANY, AND INTEREST ON THE NOTES SHALL BE PAYABLE SOLELY OUT OF THE REVENUES DERIVED FROM THE LOAN AGREEMENT OR OTHERWISE PLEDGED, ASSIGNED OR SECURED THEREUNDER AND ARE NOT OTHERWISE AN OBLIGATION OF COUNTY. THE NOTES AND INTEREST THEREON SHALL NEVER CONSTITUTE AN INDEBTEDNESS OF THE COUNTY WITHIN THE MEANING OF ANY STATE CONSTITUTIONAL PROVISION OR STATUTORY LIMITATION, AND SHALL NOT CONSTITUTE NOR GIVE RISE TO A PECUNIARY LIABILITY OF THE COUNTY OR A CHARGE AGAINST ITS GENERAL CREDIT.

<u>Section 5</u>. That the Chairman and the County Auditor are hereby authorized and directed to execute any and all documents and certificates, and do any and all things deemed necessary in order to effect the issuance and sale of the Notes and the execution and delivery of the Loan Agreement and Bond Purchase Agreement and to carry out the intent and purposes of this resolution.

<u>Section 6</u>. That the Issuer is designating the Notes as "qualified tax-exempt obligations" for the purposes of Section 265(b) of the Internal Revenue Code of 1986, as amended, to the extent that the Notes qualify for such designation.

<u>Section 7</u>. That the provisions of this resolution are hereby declared to be separable and if any section, phrase or provision shall for any reason be declared to be invalid, such declaration shall not affect the validity of the remainder of the sections, phrases and provisions.

Section 8. That all resolutions and parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.

Section 9. That this resolution shall become effective immediately upon its passage and approval.
