***Lake Canyada Update:***

To date, Mr. Kean has not received any replies to phone calls or emails and also contacted the County Attorney and was told he also had not had any replies. We are going ahead with the development plans for re-designing the treatment plant to service WLP only. The DNR could issue a Consent Order requiring us to meet specific permit requirements. This could potentially also help us to get resolution by the DNR requiring us to take Lake Canyada off of our system.

***Strategic Planning Discussion:***

The planning has changed in that we want to develop individual aspects of things we would like to see for the parks, i.e., environmental education (Wapsi). The Board will be presented with segments as they become more developed.
