

2006 Fiscal Year A Note from the Director





I am pleased to present to you the Fiscal Year 2006 Annual Report for the Scott County Health Department. A lot has happened in the past year and I would like to share a few of the highlights with you.

In May 2006, staff hosted Measles, Mumps, and Rubella (MMR) clinics at St. Ambrose and at the Scott County Administrative Center in response to the rising number of cases throughout the state and after it was discovered that many young adults did not have the second MMR shot.

In 2006, 965 radon test kits were given to or purchased by Scott County residents. As a result, several residents discovered that they had high levels of radon and have since fixed the problem.

For Public Health Month in April, staff planned a trivia night with a public health focus. Nineteen teams participated in trivia night, raising \$1,158 to benefit United Way, while at the same time, learning more about public health.




Scott County **Board of Health**
