Monitor Health Status

Communicable Disease Program

A total of five communicable diseases were reported during December. They included two cases of hepatitis C, one case of hepatitis B, and one case of salmonellosis. In January, five communicable diseases were investigated. All five were hepatitis B cases.

Iowa Department of Public Health (IDPH) began holding conference calls and webinars regarding the 2019 Novel Coronavirus that began to infect citizens in China in January. Since the initial cases, the United States has initiated level three and four travel guidance, isolation and quarantine and self-monitor guidance for individuals returning from China.

Rabies Risk Assessments

In December, nineteen individuals required rabies risk assessments after exposures to eleven dogs, seven cats, and one bat. Rabies post exposure prophylaxis was recommended for five individuals and an additional five individuals started the rabies prevention treatment prior to the bite being reported to the Health Department.

In January, fourteen individuals required rabies risk assessments after exposures to seven dogs, six cats, and two bats. There was one occurrence where two cats exposed one individual. A total of six people were recommended for the rabies prevention treatment and one additional person received the treatment prior to the bite being reported to the department.

Childhood Lead Poisoning Prevention Program

In December and January, there were eleven children receiving individual case management. Of those, five had a blood level less than 15 ug/dL, three had a blood level between 15-19 ug/dL and three had a blood lead level between 20-44 ug/dL. Ten children with an initial blood lead level between 10-14 ug/dL received supportive services (visual inspections, education over the telephone, appointment reminders) for lead poisoning during December and January. Of those, six had a blood lead level between 10-14 ug/dL and four had a blood lead level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 5 ug/dL are obtained.

Five children attending Scott County Health Department's (SCHD) Immunization Clinic accepted lead testing services during their December visit and ten children accepted the services in January. Four children were between the ages of one and two years and eleven children were between the ages of three and six years. Scott County WIC locations completed nine lead tests during December and eleven lead tests in January. No new cases of lead poisoning were identified at either location.

Staff conducted a clearance inspection of property in Davenport associated with a childhood lead poisoning case. The property passed the dust wipe clearance of the interior surfaces in October. The remaining exterior hazards were remediated and completed in January. Staff also worked with a Davenport property owner to submit an application to Live Lead Free QC

(LLFQC). The property owner is requesting assistance with replacing all of the windows in the identified property. The property owner is in the process of obtaining bids for window materials per the request of LLFQC. This property is currently associated with three children who have elevated blood lead levels.

Diagnose/Investigate Health Problems and Hazards

Sexually Transmitted Disease Program

One hundred and three individuals received sexually transmitted disease (STD) clinic services during December. Thirteen clients tested positive for chlamydia, three tested positive for gonorrhea, one client tested positive for syphilis, and one tested positive for HIV at the Health Department's clinic. In total, eighty cases of chlamydia, twenty-one cases of gonorrhea, one case of syphilis, and one HIV case were reported in Scott County during the month.

In January, seventy-five clients received STD clinic services. Six clients tested positive for chlamydia, seven clients tested positive for gonorrhea, one client tested positive for syphilis, and one client tested positive for HIV at the Health Department's clinic. In total, there were one hundred and eleven cases of chlamydia and fifty-five gonorrhea cases, one syphilis case, and one HIV cases reported in Scott County during the month.

Environmental Assessment Conducted

Staff conducted an environmental assessment at Clark's Landing restaurant in Buffalo, Iowa in response to a foodborne illness complaint. Only one complaint was received reporting that two individuals from two separate households shared a meal at the facility and both became ill with similar symptoms with similar onset times. An environmental assessment includes an interview on food handling practices as well as an inspection of the facility. The stool culture submitted by the complainant came back negative.

Evaluate Effectiveness, Accessibility and Quality

First Med Pharmacy Review

In November 2019, two hundred forty-nine inmates received nine hundred seventy-five prescriptions. Ninety-eight percent of the prescriptions were for generic medications. In December 2019, two hundred and fifty-one inmates received one thousand and twenty-one prescriptions. The use of generic medications was at ninety-nine percent.

ServSafe Quality Improvement Project Initiated

A quality improvement (QI) project idea was submitted regarding the failure rate of the ServSafe exam for English as a second language participants. The QI Council accepted the project. QI Council members facilitated three QI meetings with Environmental Health staff in January. Over the 2020 year, the team will pilot various interventions during the spring and fall scheduled ServSafe classes.

Health and Safety Checklist

Staff completed an onsite visit at a childcare center to practice the new Health and Safety Checklist. This checklist will replace the current Quality Rating System (QRS) assessments in Iowa's rebranded program, Iowa Quality for Kids (IQ4K). A date for IQ4K implementation is still to be determined. Staff will continue to practice the checklist at childcare businesses in preparation for the new program.

Follow-Up to Foodborne Illness Risk Factor Quality Improvement Project

In December 2019, Food Program staff met with the QI Council project facilitators to discuss the outcomes of the QI project focused on decreasing risk factors in food service establishments. The facilities that used the handwashing poster and the temperature and thermometer/test strips logs had a lower occurrence of these violations than the other facilities that stopped using the poster/logs. It could not be determined if these intervention strategies were responsible for the improvement, or if the facility focused on these items more since they knew inspectors would be paying particular attention to these areas. These intervention strategies are going to be revised slightly and will be provided to all new facilities with the recommendation to use them, recommended for use to facilities that have one of these violations, and required for use in facilities that have repeat violations.

I-Smile Quality Improvement Adventure

Staff participated in a two-day QI Adventure in Des Moines hosted by IDPH with four other I-Smile™ coordinators. The adventure focused on improving the dental screening certificate audit process required for all children enrolling in kindergarten and 9th grade. This QI project is a result of the oral health workgroup created following last year's failed bill proposing to eliminate health requirements. Many ideas and recommendations were shared to improve the administrative burden put on schools. These results will be shared with the workgroup and minor changes will be implemented during the 2020-2021 school year.

Develop Policies and Plans

Health Equity Committee Transitions Members

The Health Equity Committee welcomed four new committee members during the January meeting. The committee is formalizing its activities by creating a Health Equity Plan and annual workplan. The first activities included in the workplan include health equity training for new staff and investigating available national health equity assessments to adopt to allow SCHD to further understand its commitment to health equity and opportunities for moving forward.

National Infant Immunization Awareness Week Planning Underway

A Health Promotion Strategy Team was assembled to develop the plan to promote the 2020 National Infant Immunization Awareness Week. The Health Promotion Strategy Team consists of Maternal, Child, and Adolescent Health (MCAH) staff and Clinical Services staff. The group developed a plan to reach out to immunization providers, especially obstetrics/gynecology and family practice providers, as well as families with young children. Messaging will focus on getting children fully vaccinated by age two, and assuring that babies are protected from

pertussis through maternal and caregiver vaccination. The team plans to test posters and messaging with the target populations (providers and families) through the department's immunization clinic and with the Scott County Immunization Coalition. Several outreach activities are planned to help raise awareness. National Infant Immunization Week is April 25th through May 2nd.

Retail Food Safety Regulatory Association Collaborative Develops Plan

Staff attended the Retail Food Safety Regulatory Association Collaborative in January. This collaborative is made up of representatives from the National Environmental Health Association (NEHA), Association of Food and Drug Officials (AFDO), National Association of County and City Health Officials (NACHHO), Conference for Food Protection (CFP), Centers of Disease Control (CDC), the Food and Drug Administration (FDA) Office of Partnerships, FDA Office of State Cooperative Programs, and FDA Division of Programmatic Training. The goal of this collaborative is to reduce the occurrence of foodborne illness by reducing the occurrence of foodborne illness risk factor violations. The Collaborative identified six strategies that will be worked on by various partners:

- 1) Develop a national Food Code adoption strategy;
- 2) Improve the regulatory approach, competency, and food safety culture in the regulatory community;
- 3) Increase enrollment and participation in retail standards;
- 4) Improve outbreak investigations;
- 5) Increase the number of establishments with Food Safety Management Systems; and
- 6) Develop a strategy to enhance communication and better tell the food safety story.

Enforce Laws and Regulations

Immunization Audits

Immunization audits for schools were completed and reported to IDPH. Reports were emailed to the appropriate school nurses, principals, and superintendents. The total student enrollment was 29,692 for the 2019-2020 school year. Of the 29,692 students enrolled, 28,475 (95.90%) had certificates of immunization, 182 (0.61%) had provisional certificates, 950 (3.20%) children had religious exemptions, 77 (0.26%) children had medical exemptions, and 8 (0.03%) had unacceptable or no certificate (Attachment 2).

Immunization audits for childcare centers and preschools were completed and reported to IDPH. Individual and county-wide reports were sent to all of the facilities. Of the 106 sites audited, 83 were licensed childcare centers and 23 were Iowa Department of Education preschools. The total enrollment was 6,147. Of those 6,147 children, 5,901 (96%) had certificates of immunization, 46 (0.75%) had provisional certificates, 2 (0.03%) had medical exemptions, 174 (2.83%) had religious exemptions, and 24 (0.39%) had unacceptable or no certificate (Attachment 3).

Guidelines for Adjusting Frequency of Swimming Pool and Spa Inspections

Staff met to establish guidelines for increasing the frequency of swimming pool and spa inspections for facilities that had repeated significant violations. Significant violations fall under the following sections of the Iowa Swimming Pool Rules: Water Quality and Testing; Safety; and Management, Notifications, and Records. The group reviewed inspections of indoor facilities for the last two years and determined which facilities would be subject to the increased frequency if the next routine inspection shows a third occurrence of the same violation. A procedure to address repeats of these same violations for seasonal pools will be developed before seasonal pools begin to open. Swimming pool and spa operators have been informed of the potential to require additional inspections; there is a financial cost to the additional inspections.

Research for new insights and innovative solutions

Conversion to Electronic Record Storage

The department continues to work with Scott County Information Technology (IT) to transition from paper records to electronic records in the county's OnBase electronic content management software. In December and January, members of the Employee Health Program, Lead Program, Child Care Nurse Consultant Program, and Childhood Lead Poisoning Prevention Program met with IT staff to advance various scanning and record storage projects. Work is also underway to store Board of Health meeting records in the system. Some of the projects involve integration with current databases.

Focus Group for HIV Prevention Efforts

In December, staff conducted a focus group to gather community input that will inform the development of HIV prevention interventions and social marketing campaigns. This first group was organized in partnership with Redeemed Voices Worship Center, Davenport, and consisted of African American men and one Hispanic man who were engaged in the "Helping Men Excel" group at the church. Participants shared their perceptions and knowledge of HIV risk and transmission, thoughts on HIV stigma and how it has/has not changed over time, views of using

medication to prevent HIV, and perceived needs related to information and education in the African American community.

Retail Risk Factor Study Database

Staff attended a webinar designed to introduce food protection programs to the new Retail Risk Factor Study Database. The database has been developed to assist state, local, tribal, and territorial retail food protection programs in conducting an assessment on the occurrence of foodborne illness risk factors within their jurisdictions. Access to the database will provide regulatory jurisdictions with information technology support to:

- Store and track data on the occurrence of foodborne illness risk factors in food service and retail food store establishments.
- Access a secure site to maintain the integrity of the data entered for their jurisdiction.
- Produce reports on the occurrence of foodborne illness risk factors.
- Provide options for merging, sorting, and sharing data with other jurisdictions.

LiveStories Data Management and Reporting System

SCHD has purchased access to LiveStories, an online platform that allows organizations to share data interactively through reports and web-based data charts. With the LiveStories package, SCHD will have access to LiveStories' data library of public data and will have the opportunity to upload community data and make the data work interactively. LiveStories will be used for data reporting that already exists on the database as well as taking information from the Community Health Assessment report and making the data dynamic and more intriguing to the user.

Assurance

Link People to Needed Personal Health Service

Community Dental Screenings

During January, over one hundred children were screened in one day at West Children's Village by I-Smile™ staff. In December, seventy-four children were screened at various community locations and the I-Smile™ program provided ninety-seven dental screenings for Pleasant Valley High School ninth grade students to comply with the Iowa dental screening requirement.

In addition, I-Smile® Silver staff provided five oral health screenings for older adults at Luther Crest Senior Independent Living apartment complex. These seniors were linked with needed dental care. Staff also completed fifteen oral health screenings at three United States Department of Housing and Urban Development (HUD) senior apartment complexes in December. Twelve residents were assisted with care coordination/service navigation.

Potential Payment Source for Oral Health Care for Veterans

In January, staff began working with the Veterans Administration service advisor for Scott County to provide payment for dental services through the *Iowa Veterans Trust Fund*. Staff recruited three dentists who are willing to provide the required exams and treatment estimates. Payment success will not be known for approximately two months.

HIV and Hepatitis C Outreach Testing

Routine HIV and hepatitis C counseling, testing and referral services were provided in December and January at Humility of Mary Shelter, Center for Alcohol & Drug Services (CADS), Scott County Juvenile Detention Center, Safer Foundation, Center for Behavioral Health, New Horizons (Muscatine), and Alcohol and Drug Dependency Services (Burlington). In addition, a special testing event in observance of World AIDS Day was held at NorthPark Mall in December. During the two months, forty-three individuals were tested for HIV and fifteen individuals were tested for hepatitis C during routine and special testing events.

School Health Screening Conducted at Non-Public Schools

During December and January, staff conducted vision and dental screenings in the non-public schools. In total, one thousand one hundred and twenty-seven screenings were completed. Sixty-nine students were referred for additional vision services and seventeen students were referred for dental follow-up services.

Medicaid Presumptive Eligibility Services

Staff continues to help individuals and families navigate the Medicaid Presumptive Eligibility (PE) process. As a result, upon approval, the applicants are eligible for temporary Medicaid coverage. Clients are referred for services by providers, schools, department clinics, as well as through regular program interactions.

In December, staff demonstrated how to complete the PE application service for two school nurses and provided in-person PE application support for an additional school nurse while she completed the PE application process with a family. As a result of the application process, four children were approved for insurance coverage, including two needing mental health counseling services and one who was in immediate need of diabetic supplies.

Assure a Competent Public and Personal Health Workforce

Child Sexual Abuse Training

Staff attended *Stewards of Children – Ending Child Sexual Abuse* training presented by Darkness to Light. Darkness to Light is a non-profit organization that has been working to end child sexual abuse for over twenty-five years. The training taught attendees how to prevent, recognize, and react responsibly to child sexual abuse. The course also stressed the importance of adults to knowing how to respond and refer cases.

Holiday Safety Webinar

In December, staff attended the webinar *Keeping Kids and Families Safe Throughout the Holidays*. Toy and holiday decorating injuries and deaths are all too frequent. In 2017, according to the Consumer Product Safety Commission (CPSC), there were thirteen toy-related deaths and 251,700 hospital emergency visits. In addition, there were three deaths and 14,700 emergency department visits associated with holiday decorating. Several prevention methods were shared, from reading warning and age related labeling to using products tested for safety.

Make it OK Ambassador Training

Staff attended the Make It OK Ambassador Training by the Iowa Healthiest State Initiative. Make It OK is a community campaign to reduce stigma by starting conversations and increasing understanding about mental illness. A Make It Ok Ambassador is someone who has a passion for reducing mental illness stigma in his/her community. An ambassador does not need to be an expert on mental health, but someone who enjoys connecting, engaging, educating and promoting mental health awareness. Throughout the training, attendees learned about the stigma and reality of mental illness, common symptoms and mental illness diagnosis, and tips to learn what to say. At the end of the training, Make It OK Ambassadors signed a pledge and received access to various Make It OK materials such as brochures, newsletters, presentations, etc.

Health Literacy Advisor Software

In December, staff participated in a webinar hosted by Health Literacy Innovations. The department maintains an annual subscription to the company's Health Literacy Advisor software that helps assess and improve the readability of documents using plain language principles. The webinar trained and updated staff on how to utilize the software and provided further information about other resources that are available to support the use of the software. The department continues to maintain a focus on educating the community on health issues in a clear and simple manner.

Inform, Educate, and Empower People About Health Issues

Scott County Flood Response Panel Presentation

Staff participated in a panel discussion in Peoria, Illinois to educate the Peoria Region Emergency Preparedness Coalition on the 2019 Mississippi Flood Emergency Response. Department staff represented the public information officer function and shared experiences, as well as lessons learned, with the audience. Brian Payne, Scott County Emergency Management Agency (EMA) Deputy Director provided a comprehensive presentation on the flood response that addressed the PIO and public health response. This presentation will be provided to all SCHD staff at the February 2020 All Staff meeting.

I-Smile™ Trains Genesis Staff

The department's I-Smile™ and I-Smile™ Silver coordinators have been working with Genesis Hospitals on educating newly hired patient care techs (PCTs) and as of December 19th, registered nurses. The oral health education is focused on the prevention of hospital-acquired pneumonia by teaching the pathogenesis of oral bacterial plaque and proper oral care techniques.

Mobilize Community Partnerships

Maternal, Child, and Adolescent Health Program Outreach Conducted

In an effort to promote the MCAH Programs and to better connect Scott County residents to health services, staff completed in-person outreach to two faith-based groups, nine health care

offices, one library, five schools, one fitness center, and two retail locations (Dollar General and Goodwill). Kindergarten round-up materials were also delivered to the Bettendorf and Pleasant Valley school districts.

Collaborative Program with Genesis Awarded Funding from Delta Dental

I-Smile™ and I-Smile Silver™ staff have been working with Genesis Hospitals on an oral care project to reduce the incidences of hospital-acquired pneumonia (HAP). Staff helped to initiate a \$228,000 grant through Delta Dental of Iowa Foundation, which was awarded to Genesis on January 10th. Most of this grant money will be utilized to purchase quality oral care supplies for patients in all Genesis hospital locations. I-Smile™ Silver is helping to educate Genesis staff through continuing education courses and new hire orientations. This partnership with Genesis is an enormous boost in the medical dental integration movement in the area!

Scott County Kids Clinical Review/Provider Panel

Staff attended the Scott County Kids Clinical Review/Provider Panel. Jessica Sable, Behavioral Health Intervention Services (BHIS) Coordinator, from Family Resources presented about the BHIS Program. Dave Tristan presented about the Juvenile Court Services Diversion Corrective Thinking Training for juveniles that commit first time misdemeanor crimes.

Regional Group Forms to Address HIV and STD Rates

Staff attended a meeting of a recently formed group, Southeast Iowa Community Partners, which is working to address HIV and STD rates in southeast Iowa. Representatives from Great River Health System, Des Moines County Public Health, Family Planning Clinic of Southeast Iowa, Alcohol and Drug Dependency Services, and IDPH met to discuss strategies for outreach and service referrals to address rising rates of STDs in the region.

Development of a Public Health Workforce Development Playbook

Staff attended a meeting of the Public Health Accreditation Board (PHAB) Prepared Public Health Workforce. This group is made up of a representatives from IDPH, local public health departments that are involved in the PHAB process, and the Midwestern Public Health Training Center (MPHTC). Staff from MPHTC discussed a new workforce development “playbook” that is being developed. Committee members will be reviewing and contributing to the information. Some examples of topics from the playbook include: mentoring, workforce development coalition, new employee orientation, evaluation, workflow management, choosing the best training, quality improvement, and creating a culture of learning.
