Monitor Health Status

Communicable Disease Program

Two hundred and ninety-eight communicable diseases were reported during June. They included two hundred and ninety cases of COVID-19, three cases of hepatitis C, two cases of hepatitis B, two cases of campylobacteriosis, and one case of salmonellosis.

Rabies Risk Assessments

Thirty-five individuals required rabies risk assessments after exposures to seventeen dogs, six cats, seven bats, and one squirrel. Two bat exposures involved multiple people. Ten individuals received rabies post-exposure prophylaxis.

Childhood Lead Poisoning Prevention Program

In June, there were six children receiving individual case management. Of those, three had a blood lead level less than 15 ug/dL, two had a blood lead level between 15-19 ug/dL, and one had a blood lead level between 20-44 ug/dL. Ten children with an initial blood lead level between 10-14 ug/dL received supportive services (visual inspections, education over the telephone, appointment reminders) for lead poisoning this month. Of those, four had a blood lead level between 10-14 ug/dL, and six had a blood lead level less than 10 ug/dL. These children receive public health nursing support until two consecutive blood lead levels equal to or below 5 ug/dL are obtained.

Diagnose/Investigate Health Problems and Hazards

Sexually Transmitted Disease Program

Forty-eight clients received sexually transmitted disease (STD) clinic services during June. Three clients tested positive for chlamydia and five tested positive for gonorrhea at the Health Department's clinic. In total, eighty-two cases of chlamydia, twenty-seven cases of gonorrhea, and two cases of syphilis were reported in Scott County during the month.

COVID-19 Interviews and Contact Tracing

Staff from across the department have continued to interview COVID-19 patients who have positive tests, conduct contact tracing of positive cases, perform monitoring and follow-up on cases as necessary, and attend the weekly Health Care Coalition webinars for updates on COVID-19. Due to the increase in cases being seen, additional staff have been asked to complete the contract tracing training modules and may be added to the current group completing the interviews.

Lead Inspections

Staff conducted an interior lead clearance test for a property that had recently received new windows. Results from the State Hygienic Laboratory showed that all of the floors, and window troughs in two of the bedrooms, exceeded the thresholds of Iowa lead clearance standards. The property owner has plans to seal the hardwood floors and re-clean the window troughs prior to a subsequent clearance inspection.

Staff also visited a property of a new child that is receiving case management services. The initial interview was completed virtually. In an effort to be efficient/effective in staff interaction in the home, environmental staff completed a walk-through of the property to visually examine any areas that contained chipping and/or peeling of lead-based paint.

Staff responded to a complaint from a Davenport resident who voiced concerns about renovations occurring on a commercial property that is located next door to her home. The property is an old church that contains lead-based paint and the neighboring homeowner was concerned about lead-safe work practices. Staff provided education on lead-safe work practices to the owner of the commercial property. Education was also provided to the

complainant. Staff plan to drive by the property while out in the community to keep an eye on work practices as they are occurring.

Evaluate Effectiveness, Accessibility and Quality

First Med Pharmacy Review

In May, one hundred and thirty-seven inmates received five hundred and seven prescriptions. The use of generic medication was at ninety-nine percent with mental health medications at one hundred percent generic.

Administrative On-Site Reviews of Subcontractors

Staff completed virtual Administrative On-Site Reviews with Community Health Care, Inc., Center for Alcohol & Drug Services, Inc., and Genesis Health System in June. The following programs were evaluated: Lead, Immunization Services, Intervention Implementation in Target Populations, County Substance Abuse, Care For Yourself, and WISEWOMAN.

School Health Services Report

The department’s school health consultant provides services to the nine non-public schools in Scott County. Each school is given a list of services the department is able to provide and determines what services best fit its needs. At the end of the school year, each school was given a survey and asked to evaluate the services which were provided to them this year. Overall, schools were very satisfied with the services received from the school health consultant. Attachment 2 is the full report.

Immunization Benchmark Report Card

Staff ran a Benchmark Report Card for childhood and adolescent immunization rates. The report compares the individual provider organization to the immunization rates of the state and county in which organization is located. Benchmarks for children up-to-date in Scott County at twenty-four months included DTaP (4), Hepatitis B (3), MMR (1), Haemophilus Influenzae type B (3), Polio (3), Varicella (1), and Pneumococcal (4). For adolescents between the ages of thirteen and eighteen, the report is based on completion of Tdap (1), Hepatitis B (3), MMR (2), Varicella (2), and Meningococcal (1). The report also reviews the percent of adolescents that have completed the human papillomavirus (HPV) series.

The reports above are only of children that have immunization records entered into the Iowa Immunization Information Registry System (IRIS). Not all providers use IRIS.

Develop Policies and Plans

Solid Waste Hauler Ordinance Repeal Moves Forward

The Scott County Board of Supervisors held the first reading to repeal County Ordinance Chapter 32 Solid Waste Haulers. Two more readings are required to repeal the ordinance.

Guidance for Review of Mass Gatherings and Events for COVID-19 Precautions

Dr. Katz and staff have created a Mass Gathering and Events Guidance document and process for reviewing and providing recommendations for mass gatherings and events being planned in the community during the COVID-19 pandemic. Staff have been involved in the review process for multiple mass gatherings. Staff and/or the department's medical director cannot approve or disapprove plans or allow or prohibit events. The review includes feedback and recommendations. Event organizers have been open to recommendations.

Back to School Vaccine Planning

Staff reviewed vaccine inventory to determine how much vaccine is needed to be ordered for the back to school rush. Vaccine has been ordered and received. The immunization team met to begin planning back to school clinics with COVID restrictions. Extra clinics are planned for August since appointments will have longer intervals to maintain social distancing guidelines.

Review and Refresh of Mass Vaccination Clinics Begins

Staff has begun the process of reviewing current and identifying potential additional locations to support both small and large scale vaccination clinics in the future. Drive through clinics are another option being researched since they have never been held by the County before. If a COVID-19 vaccine is available in the future, the department will need to have multiple options to make the vaccination clinic process go as smoothly as possible for the public. Scott County Emergency Management is involved with this initiative.

Enforce Laws and Regulations

COVID-19 Activities Associated with Regulated Facilities

Several complaints were received throughout the month of June regarding food and beverage establishments that were not following the Governor's proclamation of maintaining six-feet of distance between tables, bar stools, and individuals/groups of individuals dining in restaurants and/or frequenting bars. Complaints were addressed on a case-by-case basis, added to the Iowa Department of Inspections and Appeals database, and forwarded to law enforcement as needed.

After the Governor's proclamation on June 10th and the extension of that proclamation on June 25th, staff received many calls with questions regarding operating at full capacity, but trying to maintain six feet social distancing. Staff spoke with many managers and owners of restaurants and bars regarding positive cases of COVID-19 at their facility or about one or more of their employees being a contact with a positive case. Staff reviewed the guidelines for disinfection of a facility for COVID-19.

Staff also spent time discussing COVID-19 guidance with pool operators. Some facilities were trying to decide whether to open due to the challenge of implementing and controlling social distancing. Staff have also spoken with pool managers/certified pool operators when cases or contacts of cases of COVID-19 have been identified and associated with a swimming pool.

Mobile Food Truck Licensing

Staff received a call from Tim Link (food inspector with the City of Dubuque Health Department) regarding a mobile food truck that was licensed out of Scott County. This is a refrigerated truck that sells frozen meat from the back of the truck or from a chest freezer placed on the ground (has a variance from DIA). The trucks are leased from Ryder and this truck and three others just had the licenses renewed in May. The Dubuque inspector noticed that the license plate on the truck did not match the license plate listed on the mobile food license. After speaking with the company, Ryder had recently swapped all four of their vehicles. Staff had three of the vehicles come to the Health Department where the new trucks were inspected and licensed. The City of Dubuque inspector inspected the truck in Dubuque and let staff know that it met the requirements for the license, which our department issued.

Research for new insights and innovative solutions

CHANGE Tool Reassessments Results Presented to City of Donahue

Staff presented the Community Health Assessment and Group Evaluation (CHANGE) Tool reassessment results to Donahue City Council. In the last year, the City of Donahue completed a sidewalk inventory, adopted a progressive tobacco and nicotine-free resolution for City parks and buildings, offered a free Hands-Only CPR training to residents, and conducted a Nutrition Environment Measures Survey – Restaurant (NEMS-R) at the Depot Bar & Grill.

Logistical Support of COVID-19 Response

Staff has continued to work within the Logistics Section of the Scott County Emergency Operations Center (EOC). The number of requests for personal protective equipment (PPE) have been declining steadily throughout the month of June; this decline encouraged the team to progress through the demobilization process. The Logistics Section dealing with medical facilities received minimal requests in the last two weeks of June. PPE manufacturers have been loosening some of the restrictions on purchasing but it is unknown if there will be any changes due to the current uptick in cases around the country. The EOC is still working to secure PPE to assure that Scott County has approximately eighteen months of supplies on hand for emergency operations, particularly for first responders.

Assurance

Link People to Needed Personal Health Service

Presumptive Eligibility Services Provided

Staff provided presumptive eligibility Medicaid services for four pregnant women, a child and a young adult. Individuals approved for temporary Medicaid are provided information on medical, dental and vision providers that accept the insurance. They are also linked to additional community resources. If a client is not approved for Medicaid, he/she is given information on the Healthcare Marketplace and Community Health Care's sliding scale fee services.

Developmental Screening

Staff conducted developmental screening virtually for a child referred from the Mississippi Bend Area Education Agency (MBAEA) for developmental monitoring. The child was determined to be on schedule for communication, gross motor, fine motor, problem-solving, personal social and social-emotional development. Copies of the screenings, report of the results, along with the consent and release paperwork, were emailed to the guardian, and MBAEA then faxed it to the child's primary care physician.

Assure a Competent Public and Personal Health Workforce

Early Child Care Webinars Related to COVID-19

Staff viewed the webinar *Addressing the Mental Health Needs of Early Childhood Education Staff During COVID-19*. The presenters reviewed common stressors for children and staff including grief and loss. Several strategies for identifying and managing stress were shared.

Staff viewed *Social Distancing in Early Care and Education: Feasible or Impossible*. The presenter shared ways to promote physical distancing in a child care setting.

COVID-19 Vaccine Webinar

Staff viewed the webinar *The Road to Immunity During COVID-19: Developing & Distributing a Vaccine*. The presenters discussed the road to immunity during COVID-19, including the basics of vaccine development, how developing a vaccine for COVID-19 differs from "traditional" vaccine development, and what actions can be taken now and in the coming months to ensure that the supply chain is ready to manufacture millions of doses of a vaccine.

Overdose Prevention Webinar

Staff viewed the training provided by Iowa Harm Reduction Coalition (IHRC) *Overdose Prevention, Naloxone Administration, & Overdose Response*. This training covered the fundamentals of overdose prevention, naloxone administration, and overdose response. IHRC takes an approach to overdose prevention that emphasizes the need to get as much naloxone as possible directly into the hands of people who are most likely to experience, witness, or reverse an overdose, minimizing any potential barrier that may arise.

Virtual Food Inspection Webinar

Staff watched the *Retail Virtual Inspections Update* webinar sponsored by the Association of Food and Drug Officials (AFDO). Due to the COVID-19 outbreak, many food safety programs are considering the implementation of various levels of virtual or telephone based inspections for retail food establishments and manufactured foods. This webinar had a panel of inspectors from several states who discussed what they have learned from implementing virtual inspections.

The National Environmental Health Association (NEHA) also hosted the webinar *Virtual Inspections During COVID-19 Pandemic*. Individuals from various entities around the country discussed how they have been handling inspections. The procedures varied with some doing only virtual inspections and others doing some in person inspections.

World Food Safety Day Webinar

Staff watched a webinar on ***Celebrating World Food Safety Day***. Sunday, June 7 marked the second annual World Food Safety Day, a day that draws attention to the importance of safe food, and inspires action to help prevent, detect, and manage foodborne risks worldwide. Frank Yiannas, Food and Drug Administration's (FDA) Deputy Commissioner for Food Policy Response, gave an update about food safety as part of the Smarter Era Initiative and challenges in light of COVID-19.

Environmental Health Communication Strategies

Staff participated in two sessions of the *Environmental Health Communications Strategies in Public Health Emergency Event: 1) Before, During, and After and 2) Partnerships and Stakeholders*. In *Before, During, and After*, Tim Hatch, Director of the Logistics and Environmental Programs for the Center for Emergency Preparedness at the Alabama Department of Public Health, reviewed the Emergency Management Disaster Cycle (Prepare, Respond, Recover, Mitigate), gave an overview of disasters, and discussed the importance of being engaged with local and state emergency management agencies.

In *Partnerships and Stakeholders*, Andrew Roszak, Executive Director of the Institute for Childhood Preparedness, discussed the importance of partnerships, explained the limitations of government entities versus the private sector counterparts, and discussed ways to establish or strengthen local partnerships.

Review of Challenges to Food Delivery

Staff watched the *AFDO Professional Series: 360 Approach to Food Delivery*. This series was designed to develop best practices, as well as provide guidance for food delivery success as individuals work to adapt to the "new normal" caused by COVID-19. A panel of scientists, educators, operators and regulators provided a 360 degree view of food safety by exploring the advantages, disadvantages, hurdles, and results experienced by a variety of food sectors and how the food safety community is managing the growing complexity of food deliveries

Webinar on Hotels, Conference, and Environmental Health in Light of COVID-19

Staff watched the webinar *Hotels, Conferences and Environmental Health During COVID-19* sponsored by the National Environmental Health Association (NEHA). This webinar focused on the current state of environmental public health in the hospitality industry. Michael Dominguez, President and CEO of Associated Luxury Hotels International, and Peter Scialla, President and COO of Delos, shared expertise on emerging hotel operations and procedures designed to promote and protect the traveling public, the meeting industry, and employees that serve it. They provided insight on how to develop hotel health and safety protocols based on COVID-19 guidelines from the Centers for Disease Control and Prevention and the World Health Organization.

Virtual Conference Opportunities

Staff watched the *AFDO 2020 Virtual Annual Education Conference Keynote Panel*. The panel of Judy McMeekin (Associate Commissioner for Regulatory Affairs, FDA), Erik Mettler (Assistant Commissioner for Partnerships and Policy, FDA), Michael Rogers (Assistant Commissioner for Human and Animal Food Operations, FDA), Elizabeth Miller (Assistant Commissioner for Medical Products and Tobacco Operations, FDA), Dan Solis (Acting Assistant Commissioner, Office of Enforcement and Import Operations, FDA), and Barbara Cassens (Director of Office of Partnerships, FDA) provided an update on regulatory affairs and food safety in the time of COVID-19. Sharon Mayl (Senior Advisor for Policy and Response, FDA) and Cassandra Taylor (Chemist, Center for Drug Evaluation and Research, FDA) discussed FDA's perspective on CBD and cannabis.

Webinar on Disinfection

Staff watched the webinar *Environmental Protection Agency (EPA) Research on Environmental Cleanup and disinfection of SARS-CoV-2*. Dr. Shawn Ryan discussed how EPA researchers are assessing the use of disinfectants on many different surfaces and objects as well as determining the best environmental sample collection methods and the limits of detection for SARS-CoV-2. To determine the effectiveness of these approaches, researchers are also developing a method to quickly analyze surface samples for the live virus, both before and after the disinfection process. Development of strategies to decontaminate "single-use" PPE are also being created at the EPA.

Iowa Department of Public Health Hosts Environmental Health Program Updates

Staff attended an Iowa Department of Public Health (IDPH) webinar regarding updates to the Tattoo and Pool Programs. Frequently asked questions and re-opening guidance for tattoo establishments and swimming pools were discussed.

Staff attended a webinar on the Grants to Counties (GTC) Program. The IDPH Environmental Health intern, Iesha Smith discussed the results of the 2020 GTC program evaluation-focus groups from winter 2020. Fiscal year 2021 program details were also provided. The amount of funds the department will receive will be slightly less. For the first time in the history of GTC, all

ninety-nine Iowa Counties will be participating in the program and program funds are divided evenly among all participating counties.

Healthy Habits Webinar

Staff attended a 5-2-1-0 Webinar that introduced the Maternal and Child Healthy Habits Toolkit. The presenters provided an overview of the newly developed toolkit as well as the 5-2-1-0 initiative facilitated by the Iowa Medical Society. The 5-2-1-0 initiative promotes 5 servings of fruits and vegetables, 2 hours or less of screen time, 1 hour or more of physical activity, and 0 sugary drinks-more water as a way to promoted healthy eating and active living for children and families.

Inform, Educate, and Empower People About Health Issues

Health Promotion Team Continues to Support Messaging

The Health Promotion Team continues to share COVID-19 messages on social media, the department's website, and through targeted emails via established listservs. In addition, the team also prepared the July Public Health Connection newsletter which shared messages about the importance of immunizations, well child exams, and fireworks safety. The team also brainstormed the highlights for the past fiscal year and made assignments to write articles for the FY20 Annual Report.

Nest Participants Receive Education

Staff presented to the Scott County Kids NEST Program via Zoom. Participants were informed about the Maternal, Child, and Adolescent Health (MCAH) Program and the benefits of Medicaid insurance. Participants were also educated on the importance and benefits of breastfeeding and provided with community resources for pregnancy and breastfeeding.

COVID-19 Community Messaging

COVID-19 community messaging has been a collaborative effort between the Scott and Rock Island County Health Departments. Coordination between the two counties has ensured that messages, methods, and timelines have mirrored and supported one another, allowing for a Quad Cities area-wide response. The Quad Cities Public Information Officer (PIO) group continues to meet once a week to connect public health, local government, and health care PIOs, and organize messages. The Scott and Rock Island County Health Departments continue to host weekly press briefings with the local media. Daily messages are shared regarding the number of positive cases in the county, testing information, and public health guidance. Community partners that are responding to COVID-19 have also joined the health departments on the call, sharing important information for providers and members of the public.

Mobilize Community Partnerships

Trauma Informed Consortium

Staff participated in the June 2020 Quad Cities Area Trauma Informed Consortium meeting. The group engaged in a discussion surrounding the intersection of trauma and systemic racism. The group is considering coordinating a panel conversation to be held on a future date.

Mississippi Bend Area Education Superintendents Meetings

Dr. Katz and staff took part in two school virtual meetings with area superintendents to discuss back to school planning and what precautions to take. These meeting will continue until the school year begins.

Food Insecurity Podcast

Department staff participated in the St. Ambrose University Institute for Person-Centered Care and Nursing faculty podcast “Address Disparities: Food Insecurities and a Pandemic”. Mike Miller, River Bend Foodbank, and Ann McGlynn, Tapestry Farms, were also part of the discussion on food insecurity and food waste data and trends during COVID-19. The podcast also discussed social determinants of health, community resources, and tips to reduce food waste at home.

Iowa Total Care Relationship Building

Members of the MCAH team met with Iowa Total Care (ITC) managed care organization representatives via WebEx. The group met to establish a relationship and learn more about ITC’s value-added benefits for members, especially for pre/postnatal women and children.

Early Childhood Iowa Professional Development Annual Meeting

Staff attended the Early Childhood Iowa (ECI) Professional Development-Health, Mental Health, and Nutrition (HMHN) Leadership Team Annual Planning Meeting. The meeting included:

- Review of the roles and responsibilities of the Leadership Team
- Updates on professional development work
- Training on system thinking
- Analysis of the ECI Executive Committee’s 2020-2021 Annual Plan
- Review of leadership teams combined survey results
- Work on the HMHN 2020-2021 Annual Plan

Annual plan priorities include building and supporting a system of early childhood coaching as well as equity across the professional development system.

Child Care Resource and Referral Communities of Practice Meeting

Staff participated in Child Care Resource and Referral’s Communities of Practice meeting via Zoom. Two meetings were held, one for centers and one for homes. Staff shared information on COVID-19 with those in attendance. Staff also provided health and safety items for door prizes and delivered them to the home and center provider winners.




Kindergarten Roundup & School Registration

Seven non-public schools received Kindergarten Roundup and School Registration services from the Scott County Health Department during the 2019-2020 school year. Of the seven schools that received the services, all (78%) reported being “very satisfied” with the service.




Audit Preparation (Immunization & Dental)

All (9) schools received Audit Preparation services during the past year (100%) and reported feeling “very satisfied” with the services received to prepare for immunization and dental audits.



Health Screenings (Vision, Hearing, Dental)



Eight schools (89%) received health screening services, including vision, hearing and dental that were provided by the Scott County Health Department. All 8 schools were very satisfied with the health screening services.





Communicable Disease & School Health Information

Communicable disease and school health information was provided by the Scott County Health Department to all 9 of the Scott County non-public schools and 100% (9) were “very satisfied” with the services.



Classroom Education (*Puberty, Handwashing, etc.*)

Seven of the nine schools surveyed received staff and classroom education services from the Scott County Health Department. 56% of the schools reported being “very satisfied” and 11% reported being “satisfied” with the services for the 2019-2020 school year.



Staff Training (*Medication Administration, Allergies, Bloodborne Pathogens*)


All nine schools surveyed received staff training services from the Scott County Health Department. 100% of the schools reported being “very satisfied” with the services for the 2019-2020 school year.






School Nurse Consultant Rating:

In addition to rating the level of satisfaction with school nursing services, schools were asked to rate the school nurse consultant assigned to their school according to her ability to carry out the following seven competencies. Respondents provided positive responses with regard to the school nurse consultant. All nine schools indicated strongly agreeing or agreeing with each of the statements regarding her abilities.



Overall Satisfaction Level

All nine schools receiving non-public school nursing services during the 2019-2020 academic year reported they were “very satisfied” with the services received.



Conclusion

Each of the nine schools receiving school nurse consultant services completed and returned surveys for the 2019-2020 school year. Of the schools responding to the survey questions regarding the school nurse consultant program, all of the schools responded they were “very satisfied” with the services they received from the school nurse consultant.

In response to questions regarding the school nurse consultant assigned to their school, the response was overwhelmingly positive. Each school reported “strongly agree” or “agree” that the school nurse consultant understood her job responsibilities and duties, recognizes problems and responds appropriately, takes initiative/ownership, has good listening skills, communicates effectively, is flexible and open-minded, and promotes mutual respect. Overall, 100% of schools responding to the overall level of satisfaction question were “very satisfied” with the school nurse consultant assigned to their school.

Due to the high level of satisfaction with the school nurse consultant and the non-public school services received, the non-public school nursing program remains an effective and high quality program serving hundreds of students within Scott County.
